Mayor Gavin Buckley City Council Remarks March 8, 2020 - 7 p.m. Virtual Meeting

### Good evening!

On March 12, it will have been a year since we were in Chambers together where I announced the State of Emergency and the city's closure for the COVID-19 pandemic. Just a few weeks, we thought back then, and we'll get the virus under control, we'll bend the curve and get back to our old routines.

That didn't happen!
It has been a tough year:

- For children who have had to figure out new routines, missed their friends and lost out on academic and educational opportunities;
- · for teens and young adults who have faced job loss and social isolation;
- for those who have experienced food insecurity, loss of income and uncertainty in their lives.
- for those who have suffered with COVID as an illness, and it has left many with long-term health effects, and
- For those who lost a family member or loved one.

It has been a year like no other in Annapolis' long history. We are a resilient City and I know we will come back stronger than before.

Please join me next Tuesday, March 16 at 6 p.m. on a Facebook LIVE event with Health Officer Nilesh Kalyanaraman and others as we look a little back on the year that was, but also look forward to how we come out of the pandemic. What the outlook is for herd immunity, for when we can expect to begin to get our old routines back.

I hope you'll join us, Tuesday, March 16 at 6 p.m. for a virtual Town Hall on YouTube and Facebook.

As you just heard from Laura Gutierrez, the Take Care health equity team has been doing a lot of work in the community throughout the pandemic. Working with our partners in the field of health care, the team literally goes door-to-door to connect people in African American and Hispanic communities to the resources they need to improve their health. They have hosted flu clinics and helped people with food and rental assistance. They have built trust and bridges to services. They have assessed and prioritized the needs of minority communities.

I am so proud of their work. Check your emails from Laura in the coming week. She is releasing a report on their work and I know you will be proud too that the City of Annapolis has been proactive and interactive. In the coming weeks, they are working with the health department to bring COVID-19 vaccination clinics to Annapolis at area churches including Mount Olive Church in Parole and Iglesia Hispana Church in Admiral Heights. To learn more, visit www.tinyURL.com/annapolisvaccines. These clinics are focused on bringing vaccines to underserved communities who qualify under vaccine priority 1A, 1B and 1C.

I know that members of the council and the community have expressed disappointment that there haven't been vaccination clinics in Annapolis. I am pleased to announce this evening that the City Manager reported to me, after conversations with the County Health Officer, that Annapolis can expect to have a vaccination clinic in April at the Pip Moyer Rec Center. These will likely be weekly clinics as more vaccine becomes available.

As many of you know, the allocation of vaccine has been limited and the health department has been working to stand up clinics in places that

accommodate very specific needs of the public and health providers. These settings include the community college and Maryland LIVE, among others.

The only other thing I wanted to talk about tonight is the passing of a resident of our community who was so beloved. On Saturday, Alderwoman Finlayson, as acting mayor, was able to present a proclamation declaring "Carlester Smith Day" to his family.

Let me read some highlights:

WHEREAS: A generation of Annapolis residents have been witness to the kindness of Carlester Smith, known as the "Walking Man" as he smiled and waved to passersby and picked up trash on daily walks in the West Street corridor and Parole community; and

WHEREAS: Carlester Smith was born in 1957 and grew up in the Obery Court community in the City of Annapolis; and

WHEREAS: Carlester Smith participated in Maryland Special Olympics as a young person, played basketball at Stanton Center and was an honorary member of the Tommy-Tom Marching band where he would march during City parades; and

WHEREAS: Carlester Smith became a staple in the community as he cleaned parking lots, washed windows and waved his trash bags on his daily expeditions; and

WHEREAS: the "Walking Man" Facebook page has more than 13,000 followers, showcasing the affection City residents have for Carlester Smith; and

WHEREAS: Carlester Smith, beloved by family, friends and complete strangers, always had a smile to offer; and

WHEREAS: Carlester Smith was called home on Monday, March 1, 2021. March 6, 2021 as Carlester Smith Day in the City of Annapolis.

I'd like it if we could now take a moment to bow our heads and send a little love up to Carlester.
