**FOR** the purpose of approving an amendment to the FY 2020 position classifications.

WHEREAS, Section 3.12.020 A. of the City Code states that the City Council "in conjunction with the adoption of the annual operating budget and whenever deemed necessary, consider the recommendations of the Civil Service Board on requests for the creation of new positions, the abolishment of positions, and the classification and reclassification of existing positions"; and

WHEREAS, on January 13, 2020, the Civil Service Board recommended a reclassification of the Senior Buyer position from A10 to A13; and

**WHEREAS**, the amended FY 2020 position classifications are attached to this Resolution.

NOW, THEREFORE,

**BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2020 pay classifications are hereby amended and adopted as attached.

AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL that this Resolution shall take effect on the date of its passage.
