### Alcoholic Beverages - Consumption on City Property

**FOR** the purpose of establishing an annual cap on fees assessed for the consumption of alcoholic beverages on City property for certain applicants.

**WHEREAS**, the FY 2020 Fees Schedule, which the City Council adopted as R-16-19, established a daily fee for a license allowing the consumption of alcoholic beverages on City property pursuant to Section 7.12.100; and

**WHEREAS**, the City Council wishes to establish an annual cap on fees assessed for an applicant that applies for a license pursuant to Section 7.12.100 used in conjunction with a special event that occurs on multiple days throughout the year.

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2020 Fees Schedule is amended as follows:

Temporary Special Class C License to Clubs

Beer .....\$50/day  
Beer, Wine and Liquor .....\$75/day

Temporary Special Class C License to Theaters

Beer, Wine and Liquor.....\$5/day  
.....NOT TO EXCEED \$100/YEAR ~~annual maximum~~

~~Application for~~Consumption on City Property LICENSE

Beer, Wine and Liquor.....\$50/day  
.....NOT TO EXCEED \$250/YEAR
