**A RESOLUTION** concerning

#### **Itinerant Merchant Sales in the Historic District - 2022**

**FOR** the purpose of authorizing hawker, peddler, and itinerant merchant sales in the Historic District as part of certain special events during calendar year 2022.

**WHEREAS**, Section 7.40.090 of the City Code allows itinerant merchant sales as part of a special event that is organized by a business association that has a principal place of business within the City of Annapolis that represents commercial enterprises in the immediate area of the proposed operation; and

**WHEREAS**, certain special events proposed for the Historic District are not organized by local business associations that have requested itinerant merchant sales; and

**WHEREAS**, Section 7.40.090.H of the City Code allows the City Council to designate certain dates and times on which hawkers, peddlers and itinerant merchants may sell in the Historic District as part of

certain special events.

**NOW THEREFORE,**

**BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that sales of merchandise in the Historic District are allowed in conjunction with the following special events and in the geographic location of these special events:

- Shamrock the Dock - Susan Campbell Park - March 6, 2022
- African Diaspora Festival - Susan Campbell Park - April 2, 2022
- Juneteenth Parade - Susan Campbell Park - June 18, 2022
- City Dock Tango - Susan Campbell Park - Second Fridays in June through September, October TBD, 2022
- Summer Concert Series/MC3 Contemporary Dance - Susan Campbell Park - Sundays in June through October, 2022
- City Dock Salsa - Susan Campbell Park - one Sunday per month TBD in June through September, 2022
- “Dueling Brushes” Paint Annapolis - Susan Campbell Park, June 5, 2022
- Race Across America - Susan Campbell Park, June 21-27, 2022
- Youth Entrepreneurship Fair - Susan Campbell Park - August 13, 2022
- Kunta Kinte Heritage Festival - Susan Campbell Park and adjacent parking, September 24, 2022
- Maritime Republic of Eastport Tug of War - Susan Campbell Park, November 5, 2022

**AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that this resolution shall take effect from the date of its passage.
