16 **A RESOLUTION** concerning

18 **Itinerant Merchant Sales in the Historic District – 2018**

19
20 **FOR** the purpose of authorizing hawker, peddler, and itinerant merchant sales in the
21 Historic District in conjunction with certain special events during calendar year
22 2018.

23
24 **WHEREAS,** Section 7.40.090 of the City Code allows itinerant merchant sales as part
25 of a special event that is organized by a business association that has a
26 principal place of business within the City of Annapolis that represents
27 commercial enterprises in the immediate area of the proposed operation;
28 and

29
30 **WHEREAS,** certain special events proposed for the Historic District are not organized
31 by local business associations that have requested itinerant merchant sales;
32 and

33
34 **WHEREAS,** Section 7.40.090 of the City Code allows the City Council to designate
35 certain dates and times on which peddlers, hawkers and itinerant
36 merchants may sell in prohibited areas; and

37
38 **WHEREAS,** on April 7, 2014, the Annapolis City Council resolved “that sales of
39 merchandise in the Historic District are allowed in conjunction only with
40 the approved special events (Flower Mart, First Sunday Art Festivals,
41 Maryland Avenue/State Circle Festivals, Race Across America, MRE
42 .05K Run, and “Dueling Brushes” Paint Annapolis) and in the geographic
43 location of the approved special events” (R-14-14); and

44
45 **WHEREAS,** on March 23, 2015, the Annapolis City Council resolved “that sales of
46 merchandise in the Historic District are allowed in conjunction with the

1 following special events and in the geographic location of these special
2 events (Maryland Avenue Street Festivals, Four Rivers Garden Club
3 Flower Sale, First Sundays, Paint Annapolis, Thursday Night with the
4 Stars, Friday Night with the Stars, L’Hermione Ship Visit, Race Across
5 America, Kunta Kinte Heritage Festival, Maritime Republic of Eastport
6 Tug of War)” (R-5-15); and

7
8 **WHEREAS,** on May 9, 2016, the Annapolis City Council resolved that “sales of
9 merchandise in the Historic District are allowed in conjunction with the
10 following special events and in the geographic location of these special
11 events (Four Rivers Garden Club Flower Sale, First Sunday Art Festivals,
12 Maryland Avenue/State Circle Street Festivals, Paint Annapolis, Race
13 Across America, Thursday Night with the Stars, Friday Night with the
14 Stars Music Festival, Kunta Kinte Heritage Festival, Maritime Republic of
15 Eastport Tug of War)” (R-8-16); and

16
17 **WHEREAS,** on March 27, 2017, the Annapolis City Council resolved that “sales of
18 merchandise in the Historic District are allowed in conjunction with the
19 following special events and in the geographic location of these special
20 events (Four Rivers Garden Club Flower Sale, Paint Annapolis, Race
21 Across America, Kunta Kinte Heritage Festival)” (R-11-17).

23 **NOW THEREFORE,**

24
25 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that sales of
26 merchandise in the Historic District are allowed in conjunction with the following special
27 events and in the geographic location of these special events as described in the
28 accompanying Staff Report:

- 30 • Brice House Community Day – East/Martin Streets, April 21
 - 31 • Four Rivers Garden Club Flower Sale – Hopkins Plaza, Sunday, April 30
 - 32 • “Dueling Brushes” Paint Annapolis – Susan Campbell Park, Sunday, June 3
 - 33 • Race Across America – Susan Campbell Park, June 19-25
 - 34 • Summer Concert Series – Susan Campbell Park, June-September
 - 35 • Kunta Kinte Heritage Festival – Susan Campbell Park and adjacent parking,
36 September 22
 - 37 • Maritime Republic of Eastport Tug of War – Susan Campbell Park, November 3
