RFP 17-21 Lease of the Annapolis Market House at City Dock - 9/11/17

MOVE THAT the Annapolis City Council directs the Administration to begin competitive negotiations for a Market House Lease with two of the Bidders, New Market and Annapolis Oyster Company. Pursuant to the City Charter the Administration is to bring the proposed leases back to the City Council for approval by Ordinance. Further, the leases are to be consistent with Ordinance 16-17 and Ordinance 17-17 and the City Code.

AND IN ADDITION THAT the Marquis Proposal is not desired,

AND IN ADDITION THAT the Administration will apprise all Alderpersons of the makeup of the lease negotiating team, which shall include two members of the City Council. Council Members will confer with the Administration on terms to include,

Among those terms the Council desires:

- A. A clear defined business plan that describes the mix of Market versus restaurant operations.
- B. Consideration of different rental rates for areas of the Market House that will be used as a market vs. areas that will be used as a restaurant selling food and beverages that are immediately consumable.
- C. Consideration of a conditional lease predicated on the bidder(s) receiving the necessary approvals from the Historic Preservation Commission and the Alcoholic Beverage Control Board. Seconded. CARRIED on voice vote.

Alderman Arnett moved to approve Alderman Budge and Alderwoman Pindell Charles as the two members of the City Council to participate on the negotiating team. Seconded. CARRIED on voice vote.
