Resolution R-41-13, Metered Parking Rates - FY 2014 Fee Schedule Revision, reduces the metered parking rates from \$2/hour to \$1/hour from January 1, 2014 through March 31, 2014. This reduction in metered parking rates cause a projected revenue shortfall in the amount of \$135,000. Due to the fact that the change in rates did not occur until January 16, 2014, the revised projected revenue shortfall is in the amount of \$112,500.

Justification for budget revision: As a requirment, ADOT must spend at lease 1% of all grant funds on training. This is based on the fiscal year total amount of grant funding; this averages out to be about \$15,000.00. The memberships are not a part of the training and education budget and should be accounted for from other sources.
