21 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**
22 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

23 **Title 11 - PUBLIC PEACE, MORALS AND WELFARE**
24 **Chapter 11.12 - Public Peace and Order**
25 **Section 11.12.095 - Street-end Park Hours**

26 **A. Tolson Street Park. A person may not enter or be present on the City property known as**
27 **Tolson Street Park, either on foot or by means of any vehicle, at any time between 10**
28 **p.m. and 7 a.m. except for the purpose of attending or participating in an activity,**
29 **program or event sponsored by or conducted under the auspices of the Department of**
30 **Recreation and Parks.**

31 **B. Tucker Street Park. A person may not enter or be present on the City property known as**
32 **Tolson Street Park, either on foot or by means of any vehicle, at any time between 10**
33 **p.m. and 7 a.m. except for the purpose of attending or participating in an activity,**
