17 **FOR** the purpose of expressly confirming the appointment of Christopher Jakubiak as the
18 Director of Planning and Zoning for the City of Annapolis; and consenting to compensate
19 the Director.

21 **WHEREAS,** pursuant to Section 3.08.030.F of the Annapolis City Code, the appointment and
22 initial salary of the Director of Planning and Zoning is subject to confirmation by
23 the City Council; and

25 **WHEREAS,** the Director of Planning and Zoning position became vacant on March 3, 2023; and

27 **WHEREAS,** Tricia Hopkins, Human Resources Manager of the City of Annapolis, conducted a
28 thorough review of Mr. Jakubiak’s qualifications and determined in her
29 professional opinion that Mr. Jakubiak’s qualifications exceed the minimum
30 requirements of the Annapolis Charter and that Mr. Jakubiak, by virtue of his
31 background, education and experience, is more than qualified to hold the position
32 of Director of Planning and Zoning; and

34 **WHEREAS,** pursuant to the foregoing City Code provision, the City Council is required to
35 expressly consent to the confirmation and compensation of the Director of Planning
36 and Zoning.

38 **NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that
39 Tricia Hopkins, Human Resources Manager of the City of Annapolis, conducted a thorough review
40 of Mr. Jakubiak’s qualifications and determined in her professional opinion that Mr. Jakubiak’s
41 qualifications exceed the minimum requirements of the Annapolis Charter and that Mr. Jakubiak,
42 by virtue of his background, education, and experience, is more than qualified to hold the position
43 of Director of Planning and Zoning.
