31 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**
32 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

33 **~~Chapter 22.02 PURPOSE~~**

34 **Section:**

35 **~~22.02.010 Purpose.~~**

36 ~~A. The purposes of testing for and certification of Adequate Public Facilities are to:~~

- 37 ~~1. Assure that development and redevelopment occurs in concert with the Capital~~
38 ~~Improvement Program and will enable the City to provide adequate public facilities~~
39 ~~in a timely manner and achieve the growth objectives of the Comprehensive Plan as~~
40 ~~defined in Title 21.~~
- 41 ~~2. Assure that proposed development protects the public health and safety, promotes~~
42 ~~the general welfare of the community, and conserves the environment.~~
- 43 ~~3. Assure that proposed development fits harmoniously into the fabric of the~~
44 ~~community.~~

1 4.— Encourage new development to occur in areas of the City where public facilities are
2 being provided.

3 B.— Adequacy standards should be achievable within a six-year timeframe and the annual
4 Capital Improvement Program should be based on a community facilities plan that insures
5 that existing deficiencies are corrected within that timeframe.

6 **Chapter 22.04 TERMS AND DEFINITIONS**

7 **22.04.010 Terms and definitions.**

8 As used in this title, the following terms shall have the meanings indicated:

9 "Adequacy" means that adequate facilities exist or are expected to exist to serve existing
10 development and the proposed project.

11 "Age-restricted residential project" means any other housing that is either:

12 1.— Provided under any state or federal program that the Secretary of Housing and Urban
13 Development determines is specifically designed and operated to assist elderly
14 persons (as defined in the state or federal program); or

15 2.— Intended for, and solely occupied by, persons sixty-two years of age or older; or

16 3.— Intended and operated for occupancy by persons fifty-five years of age or older, and:

17 a.— At least eighty percent of the occupied units are occupied by at least one person
18 who is fifty-five years of age or older; and

19 b.— The housing facility or community publishes and adheres to policies and
20 procedures that demonstrate the intent required under this subparagraph; and

21 c.— The housing facility or community complies with rules issued by the Secretary
22 of Housing and Urban Development for verification of occupancy, which shall:

23 (i) Provide for verification by reliable surveys and affidavits; and

24 (ii) Include examples of the types of policies and procedures relevant to a
25 determination of compliance with the requirement of subparagraph 3.b. Such
26 surveys and affidavits shall be admissible in administrative and judicial
27 proceedings for the purposes of such verification.

28 4.— The age restriction shall be noted on the plat and recorded in the land records for
29 Anne Arundel County.

30 "Applicant" means a person, partnership, firm, corporation, company, any other entity or
31 combination of entities, or an agent thereof, with an interest in the proposed development and
32 that undertakes or participates in the activities covered by these regulations, and that applies for a
33 Certificate of Adequate Public Facilities.

34 "Development" means the construction or enlargement of residential, commercial,
35 industrial, institutional or transportation uses or principal structures.

36 "Facilities" means:

12 ~~"Inadequacy" means that adequate facilities are not currently available to serve existing~~
13 ~~development and the proposed project.~~

14 ~~"Major site design plan" is as defined in Section 21.22.020(B)(1) for a project covered by~~
15 ~~this title.~~

16 ~~"Proposed project" means all new development or redevelopment of any non-residential~~
17 ~~building or any mixed-use development of non-residential and residential uses, proposed by an~~
18 ~~applicant, where the proposed development is greater than ten thousand square feet in area or a~~
19 ~~residential subdivision of more than eleven lots regardless of the square footage of the~~
20 ~~development.~~

21 ~~"Redevelopment" means the expansion, significant rehabilitation, alteration, reconstruction,~~
22 ~~or substantial improvement of any existing principal structure on a site, which has previously~~
23 ~~been developed. The construction of new structures on an undeveloped site is not redevelopment~~
24 ~~for purposes of this title.~~

25 ~~Chapter 22.06 APPLICABILITY~~

26 ~~22.06.010 Applicability.~~

27 ~~A Certificate of Adequate Public Facilities shall be required to be issued before any~~
28 ~~approval of a Major Site Design Plan application under Section 21.22.060 of the Zoning Code,~~
29 ~~and any approval of a Planned Developments under Chapter 21.24 of the Zoning Code, for all~~
30 ~~proposed projects subject to this title.~~

31 ~~22.06.020 Certificate of adequate public facilities.~~

32 ~~Before a Certificate of Adequate Public Facilities may be issued as required by Section~~
33 ~~22.06.010, the Department of Planning and Zoning shall receive the written findings and~~
34 ~~conclusion from each director or department responsible for the applicable facilities as to the~~
35 ~~adequacy or inadequacy of the facilities as specified in this title. No Certificate of Adequate~~
36 ~~Public Facilities shall be issued until such time as the written findings and conclusion from each~~

1 director or department responsible for the applicable facilities are delivered and which certify the
2 adequacy of the applicable facilities.

3 **Chapter 22.08 ADMINISTRATION**

4 **22.08.010 Administering Department.**

5 The Department of Planning and Zoning shall administer the application process for a
6 Certificate of Adequate Public Facilities, with support from each director or department
7 responsible for the applicable facilities. Each Department shall promulgate and publish in
8 documentary form and on the City website the standards the Department will use for certification
9 purposes.

10 **22.08.020 Submittal materials.**

11 An application for a Certificate of Adequate Public Facilities shall be made by an applicant
12 contemporaneously with any application for site design review and approval of a Major Site
13 Design Plan or Planned Development, under Title 21, for a proposed project. The applicant shall
14 provide any materials that the Department of Planning and Zoning may reasonably require to be
15 submitted. Any other materials related to an application for a Certificate of Adequate Public
16 Facilities shall be submitted to the Department of Planning and Zoning.

17 **22.08.030 Referral.**

18 The Department of Planning and Zoning shall promptly refer any and all materials related to
19 an application for a Certificate of Adequate Public Facilities to the each director or department
20 responsible for the applicable facilities for written findings, conclusion, and certification that (a)
21 the facilities are adequate for a proposed project, (b) the facilities will be adequate for a proposed
22 project because the project is in compliance with the provisions of Chapter 22.28, or (c) the
23 facilities are inadequate for a project.

24 **22.08.040 Review for and issuance of Certificate of Adequate Public Facilities.**

25 A.—After review of the application and the submitted materials in conjunction with all pertinent
26 data and measurements on the facility or facilities under review, the director of each
27 department responsible for the applicable facilities shall certify the adequacy or inadequacy
28 of the public facilities that are to serve the proposed project, based upon the standards for
29 each public facility promulgated by that director under Section 21.08.010. A written copy of
30 each department director's findings and conclusion shall be forwarded to the Planning and
31 Zoning Director.

32 B.—Subject to Section 22.26.010, if all applicable departments have certified that the proposed
33 project can be served by adequate public facilities, the Director of Planning and Zoning
34 shall issue a Certificate of Adequate Public Facilities to the applicant. If the Department of
35 Planning and Zoning finds that one or more of the departments have found inadequacy in
36 the public facilities that would serve the proposed project, no Certificate shall be issued and
37 the Director of Planning and Zoning shall notify the applicant in order that the applicant
38 may proceed in accordance with the requirements of Chapter 22.28.

1 **Chapter 22.10 GENERAL REVIEW CRITERIA**

2 **22.10.010 Development or redevelopment to be included.**

3 In determining the adequacy or inadequacy of public facilities, departments responsible for
4 the applicable facilities shall take into consideration the following:

5 A. ~~Residential, commercial, and mixed use development and approved development~~
6 ~~existing within the City, as applicable.~~

7 B. ~~Proposed projects, as applicable, for which a Certificate of Adequate Public Facilities~~
8 ~~has been issued under this title.~~

9 C. ~~The proposed project for which an application for a Certificate of Adequate Public~~
10 ~~Facilities has been applied.~~

11 D. ~~The Capital Improvement Program, including projected facilities, the~~
12 ~~Comprehensive Plan as defined in Title 21, and any other land use conditions that~~
13 ~~the Director of Planning and Zoning may reasonably prescribe to be considered by~~
14 ~~the departments.~~

15 **22.10.020 Process.**

16 A. ~~General.~~

17 1. ~~Each director or department responsible for the applicable facilities shall, for each~~
18 ~~facility, collect and maintain current information on the facility, existing levels of~~
19 ~~service, and projected levels of service.~~

20 2. ~~The Fire Chief and the Police Chief, respectively, shall each annually assess the~~
21 ~~response times for adequate fire, rescue, and emergency services, and annual~~
22 ~~assessment of officer ratio and response times for adequate police protection.~~

23 a. ~~The Fire Chief and the Police Chief, respectively, shall each assess and~~
24 ~~otherwise measure annually the facilities for which they are responsible, as~~
25 ~~described in this title, and shall each prepare a separate report of such~~
26 ~~assessments and measurements by September 1st of each year for use in~~
27 ~~conjunction with this title which shall be forwarded to the Director of Planning~~
28 ~~and Zoning.~~

29 b. ~~If the annual summary shows that the facilities meet the standards described in~~
30 ~~this title, the facilities are adequate and all projects shall be deemed to meet the~~
31 ~~adequacy standards. If the summary shows that one or more of the facilities do~~
32 ~~not meet the standards described in this title, the facilities are inadequate and~~
33 ~~applicants shall proceed in accordance with the requirements of Chapter 22.28.~~

34 3. ~~Each director or department responsible for the applicable facilities, including the~~
35 ~~Fire Chief and Police Chief, may employ persons or contract for services as may be~~
36 ~~necessary to implement such information collection and assessments as described in~~
37 ~~Subsections (2)(a) and (b).~~

38 B. ~~Procedures.~~

2 a. ~~Upon referral of any and all materials related to an application for a Certificate~~
3 ~~of Adequate Public Facilities to the each director or department responsible for~~
4 ~~the applicable facilities pursuant to Section 22.08.030, the director of the~~
5 ~~department shall assess and otherwise measure the projected levels of service of~~
6 ~~the facility or facilities as impacted by the proposed project in accordance with~~
7 ~~the standards required to be promulgated by this title. In the director's sole~~
8 ~~discretion, the director may request that an applicant provide supplemental~~
9 ~~information regarding the development or redevelopment of the proposed~~
10 ~~project and estimates of the facility services that the proposed project will~~
11 ~~demand.~~

12 b. ~~When a director's review and assessment of adequacy that is required by this~~
13 ~~title is contingent upon the findings and conclusions of another department, the~~
14 ~~director of the reviewing department shall promptly transmit copies of the~~
15 ~~materials to such other departments for written comments that include~~
16 ~~recommending a finding of adequacy or inadequacy of facilities with regard to~~
17 ~~the proposed project. Notwithstanding any recommendation, only the director or~~
18 ~~department responsible for the applicable facilities can issue a finding or~~
19 ~~conclusion as to the adequacy or inadequacy of facilities.~~

20 2. ~~Findings and Conclusion.~~

21 a. ~~Following the assessment and measurement of the projected levels of service of~~
22 ~~the facility or facilities as impacted by the proposed project and, if applicable,~~
23 ~~based upon the comment of other departments, the director or department~~
24 ~~responsible for the applicable facilities shall determine the adequacy of facilities~~
25 ~~to serve the proposed project under review.~~

26 b. ~~If a director determines that the facilities under review are or will be adequate~~
27 ~~for a proposed project, such findings and conclusions shall be forwarded to the~~
28 ~~Director of Planning and Zoning.~~

29 c. ~~If a director determines that one or more facilities is or will not be adequate for~~
30 ~~a proposed project, the applicant may proceed in accordance with the~~
31 ~~requirements of Chapter 22.28. For school capacity, see also, Section 22.25.050.~~

32 3. ~~Transmittal to Planning and Zoning Director. Upon determining that (a) the facilities~~
33 ~~are adequate for a proposed project, (b) the facilities will be adequate for a proposed~~
34 ~~project because the project is in compliance with the provisions of Chapter 22.28, or~~
35 ~~(c) the facilities are inadequate for a project, the director of the department shall~~
36 ~~forward a written copy of such findings and explanation to the Planning and Zoning~~
37 ~~Director.~~

~~Chapter 22.12 REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE FIRE, RESCUE, EMERGENCY MEDICAL AND FIRE INSPECTION 22.12.010 Responsibility.~~

~~The Fire Chief shall be responsible for review and assessment of a proposed project with regard to adequacy of fire, rescue, emergency medical, and fire inspection facilities.~~

~~22.12.020 Goal.~~

~~The goal of adequate fire, rescue, emergency medical, and fire inspection facilities is to ensure that emergency response times within the City are maintained at or above an established minimum; that the deployment resources necessary to respond to both fire and non-fire emergencies are maintained at or above an established minimum; that adequate water supply and hydrants are available for effective firefighting and fire suppression; and that an adequate fire inspection staff is maintained to perform fire and life safety inspection.~~

~~22.12.030 Exemption.~~

~~A proposed project that will include a sprinkler system or systems in accordance with Section 17.12.010 shall be deemed to have adequate facilities under this Chapter.~~

~~22.12.040 Standards.~~

~~A. The standards required to be promulgated pursuant to Section 22.08.010, shall include but not be limited to:~~

~~1. Response Times.~~

~~a. Fire incident response time for the arrival of an initial company shall be within a four minute response time and/or initial full alarm assignment within an eight-minute response time to ninety percent of incidents as measured annually in accordance with Section 22.10.020(A)(2).~~

~~b. Emergency Management Service (EMS) incident response time for the arrival of a first responder with Automated External Defibrillator (AED) shall be within a four minute response time to ninety percent of incidents as measured annually in accordance with Section 22.10.020(A)(2).~~

~~c. EMS incident response time for the arrival of an Advanced Life Support (ALS) company shall be within an eight minute response time to ninety percent of incidents as measured annually in accordance with Section 22.10.020(A)(2).~~

~~2. Fire Flow and Flow Duration. Fire flow and flow duration shall be maintained at levels of service throughout the City in compliance with the requirements of Section 17.20.020 and the State of Maryland Fire Prevention Code as adopted by the City.~~

~~Chapter 22.14 REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE POLICE PROTECTION~~

~~22.14.010 Responsibility.~~

~~The Police Chief shall be responsible for review and assessment of a proposed project's with regard to the adequacy of police protection.~~

1 **22.14.020 Goal.**

2 The goal of adequate police facilities is to ensure that law and order is maintained, the laws
3 of the City of Annapolis are enforced, and to create and sustain an environment of personal
4 safety and security of property among citizens, businesspersons, and visitors.

5 **22.14.030 Exemptions.**

6 There are no exemptions allowed for any projects.

7 **22.14.040 Standards.**

8 A. For purposes of Chapter 22.14 only, "Police Officer" means an individual who is: (1)
9 certified by the Maryland Police and Training Standards Commission; and (2) employed by
10 the Annapolis Police Department.

11 B. The standards required to be promulgated pursuant to Section 22.08.010, shall include but
12 not be limited to:

13 1. Officer Ratio. The ratio of police officers authorized in the current City budget to
14 City residents shall not be less than 3.2 officers per every one thousand City
15 residents.

16 2. Average Response Time. The average response time within the City shall not be
17 greater than two minutes and thirty seconds for a priority one emergency response
18 and for the initial annual period. Any subsequent average response time shall not
19 increase more than ten percent from the annual period immediately prior.

20 **Chapter 22.16 REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE PUBLIC**
21 **MAINTENANCE SERVICES**

22 **22.16.010 Responsibility.**

23 The Director of Public Works shall be responsible for review and assessment of a proposed
24 project with regard to the adequacy of public maintenance facilities.

25 **22.16.020 Goal.**

26 The goal of adequate public maintenance facilities is to insure that safe and efficient service
27 is provided in the areas of trash pick up, snow removal, and road maintenance.

28 **22.16.030 Exemptions.**

29 There are no exemptions allowed for any projects.

30 **22.16.040 Standards.**

31 The standards for public maintenance services, required to be promulgated pursuant to
32 Section 22.08.010, shall be determined by the Director of Public Works.

3 ~~22.18.010 Responsibility.~~

4 ~~The Director of Public Works shall be responsible for review and assessment of a proposed~~
 5 ~~project with regard to the adequacy of adequate water and sewer facilities.~~

6 ~~22.18.020 Goal.~~

7 ~~The goal of adequate water and sewer facilities is to insure that there is sufficient capacity~~
 8 ~~in the water storage system, the water distribution system, the sewer collection system, and the~~
 9 ~~sewage pumping stations owned by the municipality.~~

10 ~~22.18.030 Exemptions.~~

11 ~~There are no exemptions allowed for any projects.~~

12 ~~22.18.040 Standards.~~

13 ~~A. The standards required to be promulgated pursuant to Section 22.08.010, shall include but~~
 14 ~~not be limited to:~~

15 ~~1. Water facilities. Each project shall be served by sufficient public water for supply~~
 16 ~~and reserve capacity, as determined by the Director of Public Works in accordance~~
 17 ~~with commonly accepted standards.~~

18 ~~a. There shall be adequate storage in the facilities to satisfy the recommendations~~
 19 ~~of the American Water Works Association (AWWA).~~

20 ~~b. In the case of the water distribution system there shall be adequate capacity~~
 21 ~~within the system to be able to deliver to a fire scene a minimum of two thousand~~
 22 ~~gallons per minute of water, at a minimum residual pressure of twenty psi at~~
 23 ~~each fire hydrant.~~

24 ~~2. Sewer Facilities. Each project shall be served by sufficient public sewage for sewage~~
 25 ~~flows, as determined by the Director of Public Works in accordance with commonly~~
 26 ~~accepted standards.~~

27 ~~Chapter 22.20 REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE~~
 28 ~~RECREATIONAL FACILITIES~~

29 ~~22.20.010 Responsibility.~~

30 ~~The Director of Recreation and Parks shall be responsible for review and assessment of a~~
 31 ~~proposed project with regard to the adequacy of recreational facilities.~~

32 ~~22.20.020 Goal.~~

33 ~~The goal of adequate recreational facilities is to ensure that proposed projects contribute to~~
 34 ~~and are served by adequate recreational facilities.~~

1 **22.20.030 Exemptions.**

2 This Chapter applies to proposed projects that include residential and mixed residential and
3 commercial uses and buildings. All other proposed projects are exempt from the requirements of
4 this Chapter.

5 **22.20.040 Standards.**

6 A.—The standards required to be promulgated pursuant to Section 22.08.010, shall include but
7 not be limited to:

- 8 1.—One thousand square feet of public recreational space per each single family
9 detached dwelling unit, seven hundred fifty square feet of public recreational space
10 per each single family attached dwelling unit, and five hundred square feet of public
11 recreational space per each multifamily dwelling unit, two family dwelling unit, or
12 dwelling unit above the ground floor of nonresidential uses, within such proposed
13 project or within a public recreational facility within one-half miles of the proposed
14 project; or
- 15 2.—The fees in lieu of the provision of such public recreation space; or
- 16 3.—A combination of the above.

17 **Chapter 22.21 TRAFFIC IMPACT ANALYSES**

18 **22.21.010 Traffic impact analyses.**

19 A.—Applicability. Notwithstanding any other provisions of this title, a traffic impact analysis
20 shall be required for:

- 21 1.—A project must have a traffic impact study if:
 - 22 a.—The proposed development and/or additions to existing structure is expected to
23 generate two hundred fifty daily trips or more based upon trip generation rates
24 published in the latest edition of the Trip Generation Manual, published by the
25 Institute of Transportation Engineers (ITE); or
 - 26 b.—There are current traffic problems or issues in the project area, e.g. high traffic
27 accident frequency; or
 - 28 c.—The proposed entrances and exits from the site are too close to an intersection.
- 29 2.—Exceptions. There are no exceptions to the criteria above.

30 B.—Procedures for the preparation of traffic impact analyses

- 31 1.—The traffic impact analysis will be prepared based upon a uniform scope of work and
32 methodology for traffic impact analyses entitled Traffic Impact Analysis for
33 Proposed Development, City of Annapolis, Maryland, maintained by the Department
34 of Planning and Zoning.
- 35 2.—The traffic impact analysis will be performed under the oversight of the Department
36 of Planning and Zoning as follows:

- 1 a.—Upon a determination that a development will require a Traffic Impact Analysis,
2 the applicant will be notified of such.
- 3 b.—The Department of Planning and Zoning will prepare a scope of services for the
4 traffic impact analysis and solicit a cost estimate(s) from a competent consulting
5 firm(s) for the preparation of the analysis.
- 6 c.—The applicant will remit to the Department of Planning and Zoning sufficient
7 funds for the completion of the analysis plus an administrative fee not to exceed
8 ten percent of the projected cost of the analysis. If the completion of the analysis
9 exceeds the funds applicant remitted to the Department of Planning and Zoning,
10 the Department may withhold approval until full payment is remitted.
- 11 d.—The Department of Planning and Zoning will contract directly with the
12 consulting firm and oversee the preparation of the traffic impact analysis.
- 13 e.—All traffic analysis results will be incorporated into any Adequate Public
14 Facilities Ordinance considerations.
- 15 3.—The Department of Planning and Zoning shall be a party to all communications
16 between the project developer and the consultant performing the Traffic Impact

16 **22.08.020 - Materials.**

17 **A. Contemporaneous applications.** An application for a Certificate of Adequate Public
18 Facilities shall be made by an applicant contemporaneously with an application for site
19 design review and approval of a Major Site Design Plan or Planned Development, under
20 Title 21, for a proposed project.

21 **B. Required information.** The applicant shall provide any materials that the Director of
22 Planning and Zoning may reasonably require to be submitted. Any other materials related
23 to an application for a Certificate of Adequate Public Facilities shall be submitted to the
24 Director of Planning and Zoning.

25 **22.08.030 - Referral.**

26 The Director of Planning and Zoning shall promptly refer all materials related to an
27 application for a Certificate of Adequate Public Facilities to the director or department
28 responsible for the applicable facilities for written findings, conclusion, and certification
29 that:

- 30 1. The facilities are adequate for the proposed project, or
31 2. The facilities will be adequate for a proposed project because the project is in
32 compliance with the mitigation provisions of Chapter 22.28 of this title, or
33 3. The facilities are inadequate for a project.

34 **22.08.040 - Review and issuance of Certificate of Adequate Public Facilities.**

35 **A. Certification.** After review of the application and the submitted materials in conjunction
36 with all pertinent data and measurements on the facility or facilities under review, the
37 director of each department responsible for the applicable facilities shall certify the

1 adequacy or inadequacy of the public facilities that are to serve the proposed project,

3 **B. Departmental conclusions.** A written copy of each department director's findings and
4 conclusions shall be forwarded to the Director of Planning and Zoning Director.

5 **C. Issuance of Certificate.** Subject to the Approval or Denial Section, §22.28.010 of this
6 title, if all applicable departments have certified that the proposed project can be served
7 by adequate public facilities, the Director of Planning and Zoning shall issue a Certificate
8 of Adequate Public Facilities to the applicant.

9 **D. Non-issuance of Certificate; mitigation.** If the Director of Planning and Zoning finds
10 that one or more of the departments have found inadequacy in the public facilities that
11 would serve the proposed project, no Certificate shall be issued, and the Director of
12 Planning and Zoning shall notify the applicant so the applicant may proceed in
13 accordance with the mitigation provisions of this title.

14 15 **Chapter 22.10 - GENERAL REVIEW CRITERIA**

16 **22.10.010 - Development or redevelopment to be included.**

17 In determining the adequacy or inadequacy of public facilities, departments responsible for
18 the applicable facilities shall consider the following:

- 19 1. Residential, commercial, and mixed-use development and approved development
20 existing within the City; and
- 21 2. Proposed projects for which a Certificate of Adequate Public Facilities has been
22 issued under this Title; and
- 23 3. Proposed projects for which an application for a Certificate of Adequate Public
24 Facilities has been applied.; and
- 25 4. The Capital Improvement Program, including projected facilities, the
26 Comprehensive Plan, and any other land use conditions that the Director of
27 Planning and Zoning may reasonably prescribe to be considered by the
28 departments.

29 **22.10.020 - Process.**

30 **A. Generally.**

- 31 1. Each director or department responsible for the applicable facilities shall, for each
32 facility, collect and maintain current information on the facility, existing levels of
33 service, and projected levels of service.
- 34 2. The Fire Chief and the Police Chief shall each annually assess the response times
35 for adequate fire, rescue, and emergency services, and for the officer ratio and
36 response times for adequate police protection.

10 shall be deemed to meet the adequacy standards.

11 c. If the summary shows that one or more of the facilities do not meet the
12 standards, the facilities are inadequate, and applicants may proceed in
13 accordance with the mitigation provisions of this title.

14 3. Each director or department responsible for the applicable facilities, including the
15 Fire Chief and Police Chief, may employ persons or contract for services as may
16 be necessary to implement the information collection and assessments.

17 **B. Procedures.**

18 **1. Evaluation.**

19 a. Upon referral of all materials related to an application for a Certificate of
20 Adequate Public Facilities to each director or department responsible for
21 the applicable facilities, the director of the department shall assess and
22 otherwise measure the projected levels of service of the facility or
23 facilities as impacted by the proposed project in accordance with the
24 standards contained in this Title.

25 b. In the director's sole discretion, the director may request that an applicant
26 provide supplemental information regarding the development or
27 redevelopment of the proposed project and estimates of the facility
28 services that the proposed project will demand.

29 c. When a director's review and assessment of adequacy is contingent upon
30 the findings and conclusions of another department, the director of the
31 reviewing department shall promptly transmit copies of the materials to
32 those departments for written comments that include recommending a
33 finding of adequacy or inadequacy of facilities with regard to the proposed
34 project.

35 d. Notwithstanding any recommendation, only the director or department
36 responsible for the applicable facilities can issue findings or conclusions
37 as to the adequacy or inadequacy of facilities.

38 **2. Findings and Conclusions.**

11 with the mitigation provisions of this title.

12 **3. Transmittal to the Director of Planning and Zoning.**

13 Upon determining that (a) the facilities are adequate for a proposed project,
14 (b) the facilities will be adequate for the proposed project by virtue of a
15 mitigation plan in compliance with the provisions of this title, or (c) the
16 facilities are inadequate for a project, the director of the reviewing department
17 shall forward a written copy of the findings and conclusions to the Director of
18 Planning and Zoning.

19
20 **Chapter 22.12 - REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE**
21 **CITY ROADS AND SIDEWALK FACILITIES**

22 **22.12.010 - Responsibility.**

23 The Director of Public Works is responsible for review and assessment of a proposed
24 project with regard to the adequacy of City roads and sidewalk facilities.

25 **22.12.020 - Goal.**

26 The goal of adequate City road and sidewalk facilities is to ensure that all City roads and
27 sidewalks within the impact area of a proposed project, meaning all City roads and
28 sidewalks bordering or providing access to the property, continuous through to the first
29 intersection in all directions and including public sidewalks and corners bordering the
30 impacted public roads and intersections, meet the standards contained in this Chapter.

31 **22.12.030 - Applicability.**

32 This Chapter applies to all proposed projects.

33 **22.12.040 - Standards.**

34 The standards for adequacy of City roads and sidewalk facilities are contained in Title 21
35 of the City Code, and the following conditions also apply:

5 brick, or concrete surfaces in accordance with City of Annapolis details and
6 specifications.

8 **Chapter 22.14 - REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE**
9 **FIRE, RESCUE, AND EMERGENCY MEDICAL SERVICES**

10 **22.14.010 - Responsibility.**

11 The Fire Chief is responsible for review and assessment of a proposed project with regard
12 to adequacy of fire, rescue, and emergency medical services.

13 **22.14.020 - Goal.**

14 The goal of adequate fire, rescue, and emergency medical services is to ensure that
15 emergency response times are maintained at or above an established minimum; that the
16 deployment of resources necessary to respond to both fire and non-fire emergencies are
17 maintained at or above an established minimum; and that adequate water supply is
18 available for effective firefighting and fire suppression.

19 **22.14.030 – Applicability.**

20 A proposed project is exempt from the adequate fire flow and flow duration requirements
21 of the National Fire Protection Association codes and standards if the proposed project
22 includes a sprinkler system not required by law. Otherwise, this Chapter applies to all
23 proposed projects.

24 **22.14.040 - Standards.**

25 **A. Standards.** The standards required for adequacy of fire, rescue, and emergency medical
26 services are:

27 **1. Response Times.**

28 a. Fire incident response time for the arrival of an initial company shall be
29 within a four-minute response time or initial full alarm assignment within
30 an eight-minute response time to 90% of incidents as measured annually
31 in accordance with Section 22.10.020 of this title.

32 b. Emergency Medical Services (EMS) incident response time for the arrival
33 of a first responder with an Automated External Defibrillator (AED) shall
34 be within a four-minute response time to 90% of incidents as measured
35 annually in accordance with Section 22.10.020 of this title.

36 c. Emergency Medical Services (EMS) incident response time for the arrival
37 of an Advanced Life Support (ALS) company shall be within an eight-

7 **ADEQUATE NON-AUTO TRANSPORTATION FACILITIES**

8 **22.16.010 - Responsibility.**

9 The Director of Planning and Zoning is responsible for review and assessment of a
10 proposed project with regard to the adequacy of non-auto transportation facilities. The
11 review and assessment shall consider recommendations of the Director of Transportation.

12 **22.16.020 - Goal.**

13 The goal of adequate bicycle, pedestrian, and transit facilities is to increase accessibility
14 and to ensure reasonable and assessable alternatives to automobile travel.

15 **22.16.030 - Applicability.**

16 This Chapter applies to all proposed projects.

17 **22.16.040 - Standards.**

18 The standards required for non-auto transportation facilities are:

- 19 1. **Bicycle Facilities.** Proposed projects shall be served by adequate bicycle facilities
20 throughout the site.
- 21 2. **Pedestrian Facilities.** Proposed projects shall be served by sidewalks where
22 necessary throughout the site, constructed to City standards.
- 23 3. **Transit Facilities.** If a proposed project abuts an existing or planned bus line, the
24 proposed project shall be served by a bus shelter at all existing and planned bus
25 stops on roadways throughout the proposed project.
- 26 4. **Signalized Intersections.** Signalized intersections adjacent to proposed projects
27 shall have the appurtenances necessary for adequate bicycle, pedestrian, and
28 transit facilities, including crosswalks, signals, and non-auto curb cuts.

29
30 **Chapter 22.18 - REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE**
31 **POLICE PROTECTION**

32 **22.18.010 - Responsibility.**

33 The Police Chief is responsible for review and assessment of a proposed project with
34 regard to the adequacy of police protection.

6 This Chapter applies to all proposed projects.

7 22.18.040 - Standards.

8 A. Definition. For purposes of this Chapter only, "Police Officer" means an individual who
9 is:

- 10 1. certified by the Maryland Police and Training Standards Commission; and
11 2. employed by the Annapolis Police Department.

12 B. Standards. The standards for the adequacy of police protection are:

- 13 1. Officer Ratio. The ratio of police officers authorized in the current City budget to
14 City residents shall not be less than 3.2 officers per every 1,000 City residents.
15 2. Average Response Time. The average response time within the City shall not be
16 greater than two minutes and 30 seconds for a priority one emergency response
17 and for the initial annual period. Any subsequent average response time may not
18 increase more than 10% from the annual period immediately prior.

19

20 **Chapter 22.20 - REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE**
21 **RECREATIONAL FACILITIES**

22 22.20.010 - Responsibility.

23 The Director of Recreation and Parks is responsible for review and assessment of a
24 proposed project with regard to the adequacy of recreational facilities.

25 22.20.020 - Goal.

26 The goal of adequate recreational facilities is to ensure that proposed projects contribute to
27 and are served by adequate recreational facilities.

28 22.20.030 - Applicability.

29 This Chapter applies to proposed projects that include residential, whether or not
30 combined with other uses. This Chapter does not apply to other proposed projects.

31 22.20.040 - Standards.

32 The standards for adequate recreational facilities are as follows:

- 33 1. The applicant shall:
34 a. Provide:

10 into a designated fund to be administered by the Director of Recreation
11 and Parks; or

- 13 2. Public recreational space shall be located within the proposed project or within a
14 public recreational facility within one-half mile of the proposed project.

15
16 **Chapter 22.22 - REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE**
17 **SCHOOL FACILITIES**

18 **22.22.010 - Responsibility.**

19 The Director of Planning and Zoning is responsible for review and assessment of a
20 proposed project with regard to the adequacy of school facilities.

21 **22.22.020 - Goal.**

22 The goal of reviewing and assessing adequate school facilities is to ensure that the
23 proposed project is served by public schools that do not exceed the capacities set forth in
24 Section 22.22.040 of this title.

25 **22.22.030 - Applicability.**

26 This Chapter does not apply to the following proposed projects:

- 27 1. Non-residential projects; and
- 28 2. Residential subdivisions if no new dwelling unit potential is created; and
- 29 3. Efficiency and one-bedroom dwelling units within the proposed development; and
- 30 4. Institutions for the care of the aged; and
- 31 5. Proposed projects in (1) the arts and entertainment district and (2) the boundaries
32 as established by the Main Street Maryland Letter of Agreement for Designated
33 Communities as shown on the Annapolis Main Street District Map dated 3/9/16;
34 and
- 35 6. Age-restricted residential projects; and

5 Income Housing Tax Credit Program, as long as school pupil generation factors

7 Master Plan, is currently or projected to be under 120% capacity for any
8 individual school serving the area to be developed.

9 Otherwise, all proposed projects are subject to this Chapter.

10 22.22.040 - Standards.

11 A. **Utilization chart.** The creation of a school utilization chart in accordance with paragraph
12 D. of this section shall occur on January 1 and July 1 of each year. The Director of
13 Planning and Zoning shall prepare a school utilization chart for use on both of these dates
14 each year.

15 B. **Testing.** Testing for adequate school capacities is prepared by the Director of Planning
16 and Zoning and is based on the school utilization chart, as described in paragraph D.

17 C. **Not allowed.** Notwithstanding the definition of "proposed project" in Section 22.04.010
18 of this title, residential developments exceeding five dwelling units may not be approved
19 at locations where:

20 1. The enrollment at the elementary and middle schools that serve the site, including
21 enrollment at the elementary and middle schools from the proposed development
22 and the number of elementary and middle schools students expected to attend
23 based on the school pupil generation factors yield per unit contained in the Anne
24 Arundel County Educational Facilities Master Plan, is currently or projected to be
25 equal to or greater than 100% of the state rated capacity within three years, except
26 that students who do not reside in the feeder system are excluded from the
27 calculation; and

28 2. The enrollment at the high school that serves the site, including enrollment at the
29 high school from the proposed development and the number of high school
30 students expected to attend based on the school pupil generation factors yield per
31 unit contained in the Anne Arundel County Educational Facilities Master Plan, is
32 currently or projected to be equal to or greater than 100% of the state rated
33 capacity within three years, except that students who do not reside in the feeder
34 system are excluded from the calculation.

35 D. **Utilization chart contents.** Except as otherwise provided in this chapter, the school
36 capacity used in the school utilization chart shall include the following and shall not vary
37 in substance from the information included in the Anne Arundel County Educational
38 Facilities Master Plan unless the variation is confirmed in writing by the Superintendent
39 of the School Board or the Superintendent's designee, or is approved by resolution of the
40 City Council:

11 the future capacity is included in the school utilization chart; and
 - 12 c. The capacity does not include capacity based on temporary or relocatable
13 structures.

14 **22.22.050 - Notice to the applicant regarding completion of applications.**

15 **A. Completed application.** Within 14 days of the date upon which the Director of Planning
16 and Zoning determines that an application for a certificate of adequate public facilities
17 and corresponding application under Title 21 of the City Code is deemed complete, the
18 Director of Planning and Zoning shall notify the applicant in writing whether the
19 application is deemed complete for purposes of this chapter.

20 **B. Incomplete application.** If the application is not deemed complete, the Director shall
21 specify any additional information needed to complete the application.

22 **C. Application extensions.** The Director may extend the deadline for notification for up to
23 an additional 14 days, with written notice to the applicant.

24

25 **Chapter 22.24 - REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE**
26 **STORM DRAIN FACILITIES**

27 **22.24.010 - Responsibility.**

28 The Director of Public Works is responsible for review and assessment of a proposed
29 project with regard to the adequacy of storm drain facilities.

30 **22.24.020 - Goal.**

31 The goal of adequate storm drain facilities is to ensure that all public and private
32 stormwater infrastructure, as installed within a receiving drainage area, is capable of
33 handling a 10-year storm as calculated prior to installation. Consideration will be given to
34 any existing or proposed infrastructure within the study area downstream of the point of
35 discharge.

10 year storm to an adequate outfall.

12 **Chapter 22.26 - REVIEW CRITERIA AND CERTIFICATION FOR ADEQUATE**
13 **WATER AND SEWER FACILITIES**

14 22.26.010 - Responsibility.

15 The Director of Public Works is responsible for review and assessment of a proposed
16 project with regard to the adequacy of adequate water and sewer facilities.

17 22.26.020 - Goal.

18 The goal of adequate water and sewer facilities is to ensure that there is sufficient
19 capacity in the City-owned water source, storage, pumping, and distribution systems, the
20 City-owned sewer collection and pumping systems, and the City co-owned Annapolis
21 Water Reclamation Facility.

22 22. 26.030 - Applicability.

23 This Chapter applies to all proposed projects.

24 22. 26.040 - Standards.

25 After accounting for all existing and future demands and flows, the standards for the
26 adequacy of water and sewer facilities are:

- 27 1. **Water facilities.** A proposed project shall be served by sufficient public water for
28 supply and reserve capacity, as follows:
 - 29 a. The source facilities in the area have sufficient available capacity to
30 provide maximum day demand to the proposed project.
 - 31 b. The storage tanks in the area have sufficient available capacity to provide
32 peak hour demand in addition to fire flow and flow duration in accordance
33 with the National Fire Protection Association codes and standards.
 - 34 c. Local pumping stations provide water to the proposed project with
35 sufficient available capacity to provide maximum day demand when

6 City's water system under fire flow requirements for the project in
7 accordance with the National Fire Protection Association codes and
8 standards.

9 **2. Sewer Facilities.** A proposed project shall be served by sufficient public sewer
10 facilities for sewage flows, as follows:

11 a. Laterals in the right-of-way accommodate expected peak flows from the
12 proposed project.

13 b. Collectors and interceptors accommodate expected peak gravity flows
14 from the proposed project with adjustments for pump flows if applicable.

15 c. Pumping stations and force mains tributary to the project area
16 accommodate expected peak flows from the proposed project.

17 d. The Annapolis Water Reclamation Facility's allocated City capacity
18 accommodates the expected peak flows from the proposed project.

19
20 **Chapter 22.28 - APPROVAL OR DENIAL OF CERTIFICATE OF ADEQUATE PUBLIC**
21 **FACILITIES**

22 **22.28.010 - Approval.**

23 **A. Issuance.** Upon determining the adequacy of all facilities, or that all facilities will be
24 adequate by a mitigation plan in compliance with this Title, the Director of Planning and
25 Zoning shall approve the application for a Certificate of Adequate Public Facilities by
26 issuing the Certificate to the applicant.

27 **B. When approval of Major Site Design Plan is prohibited.** The Planning and Zoning
28 Director may not approve an application for a Major Site Design Plan until the applicant
29 is issued a Certificate of Adequate Public Facilities.

30 **22.28.020 - Denial; waiting list.**

31 If there is a determination of inadequacy of one or more of the facilities in this Chapter
32 and if the applicant has submitted no mitigation plan in compliance with this Title, the
33 Director of Planning and Zoning shall:

34 1. Issue to the applicant a denial of the application for a Certificate of Adequate of
35 Public Facilities for the proposed project; or

1 2. Upon the applicant's request, place the proposed project on a waiting list
2 established and maintained by the Department of Planning and Zoning in
3 consultation with the applicable departments.

4 3. As facilities become adequate for a proposed project on the waiting list because
5 the adequacy standards have been satisfied or because the applicant has submitted
6 a mitigation plan under Chapter 22.28 of this title, the Director of Planning and
7 Zoning shall approve the application for a Certificate of Adequate Public
8 Facilities for the proposed project by issuing the Certificate to the applicant.

9 **22.28.030 - Approval pursuant to funding for facilities.**

10 The facility shall be deemed adequate if a facility is scheduled to be improved under any
11 relevant capital improvement program of the City, County, State, or any relevant agency
12 and is funded for construction.

13 **22.28.040 - Phased development.**

14 The Director of Planning and Zoning may issue a Certificate of Adequate Public
15 Facilities in conjunction with a Major Site Design Plan approval for an entire proposed
16 project or, at the request of the applicant, the Director may issue separate and successive
17 Certificates of Adequate Public Facilities for phases of the proposed project.

18 **22.28.050 - Resubmittal.**

19 An application for a Certificate of Adequate Public Facilities that is not placed on the
20 waiting list pursuant to Subsection 22.28.020 of this title, but is denied under Subsection
21 22.28.020 of this title, may not be resubmitted by an applicant until after six months from
22 the date of denial.

23
24 **Chapter 22.30 - MITIGATION**

25 **22.30.010 - Opportunity to mitigate.**

26 A. **Generally.** An applicant whose proposed project is subject to denial or delay under this
27 Title shall be given an opportunity to provide infrastructure funds, improve facilities
28 directly, or donate necessary facilities to approve the applicant's application under this
29 title for a Certificate for Adequate Public Facilities.

30 1. The capacity, safety or other facility standard after mitigation shall be roughly
31 proportional to levels prior to the proposed project's development, as determined
32 by the Director of Planning and Zoning in consultation with the other departments
33 responsible for the applicable facility.

34 2. A mitigation plan shall include all information required by the Director of
35 Planning and Zoning and all information required by applicable departments.

36 **B. City roads and sidewalks.**

- 1 1. For an inadequate City road facility, mitigation may include repairing the public
2 road to full width, with a minimum of a two-inch bituminous concrete overlay.
3 Public roadways that do not have a bituminous concrete, brick, or concrete
4 surface shall be properly graded and paved using the Type 3, light-duty road
5 paving section.
- 6 2. The pavement width and the need for curb and gutter, sidewalk, and storm
7 drainage to be constructed as part of the roadway is determined by the
8 Department of Public Works.
- 9 3. For an inadequate sidewalk facility, mitigation may include sidewalk extensions,
10 connections, repairs, and widening, as determined by the Department of Public
11 Works.

12 **C. Fire, rescue, and emergency medical services.**

- 13 1. For the response times set forth in this Title, the mitigation may include the
14 building of a fire station, paying into a specified fund an agreed-upon amount of
15 money for a specified amount of time to assist the City in building a fire station or
16 paying into a specified fund an agreed upon amount of money for a set amount of
17 time to assist the City in hiring and retaining additional personnel.
- 18 2. For fire flow and flow duration standards set forth in this Title, the mitigation may
19 include building a private fire protection water supply approved by the Director of
20 Planning and Zoning after consultation with other applicable departments.

21 **D. Non-auto transportation.** The mitigation for inadequate non-auto transportation
22 facilities may include offsite bicycle facilities, offsite pedestrian facilities, offsite transit
23 facilities, and offsite signalized intersections.

24 **E. Police protection.**

- 25 1. If the Chief of Police determines that a planned development or redevelopment
26 would negatively impact the City's ability to provide the required level of police
27 service based on the officer ratio set forth in this Title, the Chief of Police may
28 require, as mitigation, that the applicant provide or contribute, concurrent with the
29 project, measures sufficient to equal or exceed the required level of service, as
30 follows:
 - 31 a. Security enhancements, including Annapolis Police Department
32 compatible security cameras, the hiring of off-duty police officers, the
33 hiring of private security, the hiring of contractual City Police officers, or
34 other measures approved by the Chief of Police and City Manager; or
 - 35 b. Social services enhancements, including hiring of a private social worker,
36 the hiring of contractual City social workers, or other measures approved
37 by the Chief of Police and City Manager; or
 - 38 c. A combination of security and social services enhancements approved by
39 the Chief of Police and City Manager; or

- 1 d. The building of a police station; or
2 e. Paying an agreed-upon amount of money for a specified amount of time to
3 assist the City in building a police station; or
4 f. Paying an agreed-upon amount of money for a specified amount of time to
5 assist the City in hiring and retaining additional personnel.

6 **F. Schools.**

- 7 1. For a school facility, mitigation consists of the construction or funding of
8 improvements by a developer that increases the capacity of the school facility,
9 which, at the time of the application, is below the minimum standard in the impact
10 area so that the capacity of the facility in the scheduled completion year is equal
11 to, or greater than, it would have been had the development not been constructed.
12 A mitigation plan with physical improvements may be secured by a bond, a letter
13 of credit, or other security acceptable to the City. It shall be provided under an
14 agreement with the Board of Education to construct school facilities, including
15 contract schools.
16 2. The developer shall submit a cost estimate to establish the value of construction
17 offered in mitigation in conformance with City specifications. Capital
18 improvements to any portion of the developer’s property or project, pursuant to a
19 school capacity mitigation agreement, shall be made available and shall provide
20 school capacity to allow approval of preliminary subdivision plan applications
21 that are filed within six years of the date of the school capacity mitigation
22 agreement.

23 **G. Storm drains.** For inadequate storm drain systems, mitigation may include increased
24 stormwater management, the design, construction, or repair of stormwater pipes, utility
25 holes, conveyances, storage, or outfalls, and the payment of a fee, as provided in a
26 resolution adopted by the City Council, which fee shall be deposited into a designated
27 fund to be administered by the Director of Public Works.

28 **H. Water and sewer.**

- 29 1. For the required water pressure set forth in this Title, mitigation may include
30 designing and constructing a water pressure zone.
31 2. For laterals, collectors, and interceptors that cannot accommodate peak flows as
32 set forth in this Title, mitigation may include the replacement of pipes with larger
33 pipes.
34 3. For pumping stations that cannot accommodate peak flows as set forth in this
35 Title, mitigation may include the design and construction of new pumps, a
36 pumping station, or a force main.

37 **22.30.020 – Process.**

1 **A. Mitigation plan.** To determine the appropriate forms and levels of mitigation, an
2 applicant shall consult with the department responsible for reviewing and assessing each
3 facility that would be deemed inadequate.

4 1. Once the applicant and the department agree upon the forms and levels of
5 mitigation that will offset the project's impact on the facility, the applicant shall
6 enter into a mitigation plan on terms and conditions acceptable to the Department
7 of Planning and Zoning.

8 2. The mitigation plan shall require the applicant to provide the agreed-upon
9 mitigation. In return, the Director of Planning and Zoning shall determine that the
10 facility or facilities will be adequate for the proposed project.

11 **B. Inadequacy due to more than one project.** If a department finds that a facility is or
12 would be inadequate due to more than one proposed project, the department may
13 apportion the responsibility and cost of mitigation among all contributing projects. The
14 apportionment shall be reflected in the applicable mitigation plans.

15 **C. Approval of the plan.** A mitigation plan shall be approved by the Director of Planning
16 and Zoning and by the department responsible for the facility.

17 **D. Applicant rejects mitigation.** If a facility is inadequate for a project and the applicant
18 cannot agree on acceptable forms and levels of mitigation for the facility such that the
19 applicant enters into no mitigation plan, the department shall determine that the facility is
20 inadequate to support the project.

21 **Chapter 22.35 - TIMING OF CERTIFICATION**

22 **22.35.010 – Expiration.**

23 **A. At the end of five years.** Unless extended under Section 22.35.020 of this title, a
24 Certificate of Adequate Public Facilities shall expire at the end of five years from the date
25 of issuance unless:

26 1. The applicant has recorded a plat or plats for the proposed project; or

27 2. The applicant has obtained a building permit for any part of the proposed project.

28 **B. New application.** If a Certificate of Adequate Public Facilities expires, a new application
29 for a Certificate shall be required for the proposed project. Upon a new application, the
30 facilities existing or planned at the time of the new application shall control.

31 **22.35.020 – Extensions.**

32 **A. When request must be submitted.** A request to extend the time of expiration of a
33 Certificate of Adequate Public Facilities shall be submitted to the Director of Planning
34 and Zoning before the expiration of the original approval.

35 **B. Good cause.** The Director of Planning and Zoning shall extend a Certificate of Adequate
36 Public Facilities for up to two five-year periods from the expiration of the original
37 approval.

1 approval or any extended approval upon a showing of good cause if intervening
2 approvals of Certificates of Adequate Public Facilities for other proposed projects taking
3 into consideration the proposed project's impact on facilities, as required by Subsection
4 22.10.010 of this title.

5 **22.35.030 - Recertification.**

6 **A. Application after expiration.** An application for a Certificate of Adequate Public
7 Facilities that had been previously approved but had expired shall be submitted to the
8 Director of Planning and Zoning.

9 **B. Updates.** The application shall be based upon updated materials and analyses of all
10 applicable facilities and standards under this title.

11 **C Evaluation of development or remaining development.** The materials and analyses
12 shall include an evaluation of the development or remaining development scheduled to be
13 completed as part of the proposed project as compared to any infrastructure that has
14 already been provided for the project.

15 **D. Mitigation.** If the materials and analyses indicate that one or more facilities will not be
16 adequate for the proposed project, the applicant may proceed in accordance with the
17 mitigation requirements of this title.

18
19 **Chapter 22.40 - APPEALS**

20 **22.40.010 - Appeals.**

21 Any appeal from the decision of the Director of Planning and Zoning to approve or deny
22 an application for a Certificate of Adequate Public Facilities shall be made to the Board
23 of Appeals in conformance with Chapter 21.30 in the Planning and Zoning title of the
24 City Code.

25 **22.40.020 - Pending appeal.**

26 An appeal stays all proceedings in furtherance of the action appealed.
27
