THIS DEED, made this 19th day of June, in the year nineteen hundred and fifty-one, by the COUNTY COMMISSIONERS OF ANNE ARUNDEL COUNTY, a body corporate of the State of Maryland, party of the first part and the MAYOR AND ALDERMEN OF THE CITY OF ANNAPOLIS, a municipal corporation of the State of Maryland, party of the second part.

WITNESSETH that for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations, the receipt whereof is hereby acknowledged, the said party of the first part does hereby grant and convey unto the said party of the second part, its successors and assigns, all its right, title and interest in and to the following strips and parcels of land, and easements and rights of way, situate, lying and being in the Sixth Election District of Anne Arundel County, State of Maryland, and more particularly described as follows:

BEING all those strips or parcels of land comprising the street and roads, and all easements and rights of way, heretofore granted and conveyed unto, or otherwise acquired by, the party of the first part, or dedicated or abandoned to the use of the party of the first part, for the uses and purposes of public streets or roads, rights of way, or easements, which are situate, lying and being in that former portion of the Second Election District of Anne Arundel County, State of Maryland, which by Chapter 696 of the Acts of the Maryland General Assembly, enacted in the year 1949, was authorized to be annexed to and to become a part of the City of Annapolis, State of Maryland, and which former portion of the Second Election District of Anne Arundel County, State of Maryland, is now located within the boundaries of the City of Annapolis and the Sixth Election District of Anne Arundel County, State of Maryland, by Chapter 569 of the Acts of the Maryland

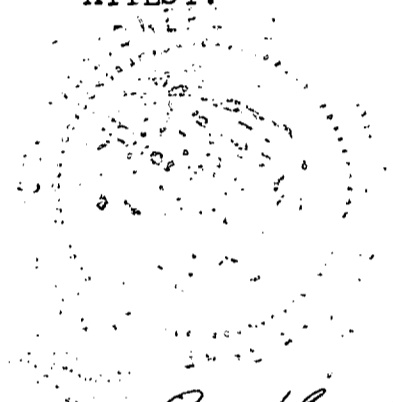

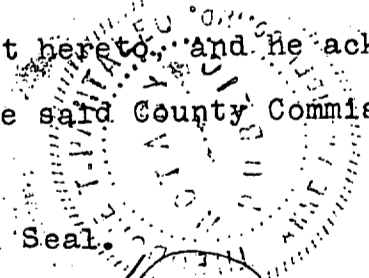
