

In my role I coordinated with all stakeholders, from the executive office to work floor operations to introduce new technologies in bus and rail to improve on-time performance and enhance passenger information. For a period of 4 years I was based in Cedar Rapids, IA, followed by 3 years working from Switzerland.

Additionally, my interest in improving the quality of life in the capital of Maryland by ensuring good transportation options for the citizens and visitors, combined with my engagements with many American and international cities and understanding the fast changes in new technologies, can contribute to exemplary policies and plans which can be realized in the near and mid-term future.
