

City of Annapolis Community Grant Funding Requests

The FY 2017 Community Grant Applications have been organized into the service categories outlined in the City Code §6.16.060(b), with subcategories added in some instances, to aid the reader in quickly identifying the purpose of the program. There are three "Proposed" funding columns. Each column represents a different funding level: \$205,000, the Mayor's Proposed Budget; \$400,000, the Finance Committee amendment funding level; and \$302,500, which represents a median level increase in the grant funding.
