15 **A RESOLUTION** concerning

16
17 **Commission to Plan Celebrations for the 250th Anniversary**
18 **of the United States of America**

20 **FOR** the purpose of creating the United States of America semiquincentennial
21 commission to plan celebrations in the City of Annapolis commemorating the 250th
22 anniversary of the U.S.A.

25 **WHEREAS,** On July 4, 2026, the United States will celebrate the 250th anniversary of
26 its founding; and

27
28 **WHEREAS,** This is a momentous occasion that should be commemorated with a variety
29 of events and activities that reflect the diversity and strength of our nation
30 and the role that the City of Annapolis had in its founding; and

32 **WHEREAS,** The City of Annapolis was pivotal in the founding of the U.S., not only as
33 the capital of Maryland during the Revolutionary War but also:

- 35 ● 1774 - The First Continental Congress met in Annapolis,
 - 36 ● 1783 - The Treaty of Paris was signed in Annapolis, which officially ended the Revolutionary War,
 - 37 ● 1783 and 1784 - Annapolis was the temporary U.S. capital and home
 - 38 of the Continental Congress, and
 - 39 ● 1787 - Annapolis was the site of the Constitutional Convention; and

1 **WHEREAS,** In 2026, Annapolis will be a significant center for celebrations of the 250th
2 anniversary of the U.S. as the City commemorates the role of Historic
3 Annapolis in the establishment of the United States; and
4

5 **WHEREAS,** The City of Annapolis recognizes the importance of engaging its citizens,
6 businesses, educational institutions, and various organizations in
7 celebrating the U.S. Semiquincentennial and fostering a greater
8 understanding and appreciation of American history, culture and
9 achievements.
10

11 **NOW THEREFORE,**

12 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that:

- 13
- 14 1. There is hereby created the “Annapolis U.S. Semiquincentennial Commission” to
15 plan and coordinate the City of Annapolis celebrations for the 250th anniversary of
16 the United States of America; and
 - 17 2. The Commission shall:
 - 18 a. Consist of nine to 15 members, appointed by the Mayor and confirmed by
19 the City Council, representing various sectors of the community, including
20 two City of Annapolis residents and no more than one representative from
21 each of the following groups:
 - 22 i. The Annapolis Mayor's office; and
 - 23 ii. Visit Annapolis & Anne Arundel County (VAAAC); and
 - 24 iii. Historic Annapolis Foundation; and
 - 25 iv. Banneker-Douglass Museum; and
 - 26 v. Anne Arundel County; and
 - 27 vi. Maryland State Senate; and
 - 28 vii. Annapolis Historic Preservation Commission; and
 - 29 viii. Four Rivers: The Heritage Area of Annapolis, London Town &
30 South County Heritage Area (Four Rivers Heritage Area); and
 - 31 ix. City of Annapolis business community; and
 - 32 x. Arts Council of Anne Arundel County; and
 - 33 xi. Maryland Hall; and
 - 34 xii. National Parks Service.
 - 35 b. Meet at least quarterly to plan and coordinate the celebrations through 2026;
 - 36 c. Submit a quarterly report to the Mayor and City Council on its activities,
37 ensuring transparency and accountability.
 - 38 3. A quorum of the Annapolis U.S. Semiquincentennial Commission shall be no fewer
39 than seven members in attendance at meetings, and a majority for voting purposes
40 is a majority of those commissioners present.

- 1 4. Commission duties include and are not limited to:
- 2 a. Developing a plan for the commemoration of the U.S. Semiquincentennial
- 3 in Annapolis, outline specific events, programs and initiatives that align
- 4 with the city's historical significance and cultural heritage; and
- 5 b. Identifying and securing funding for the celebrations by seeking grants,
- 6 sponsorships and donations while also exploring partnerships with county,
- 7 state and federal agencies dedicated to the U.S. Semiquincentennial; and
- 8 c. Coordinating with local, county, and state agencies to ensure the smooth
- 9 operation of the celebrations; and
- 10 d. Submit a report to the City Council three months after the final event, at
- 11 which time the commission shall dissolve; the report will evaluate the
- 12 celebrations' success and make recommendations for future celebrations in
- 13 the City of Annapolis.

14 **AND BE IT FINALLY RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that

15 this resolution shall take effect upon passage.
