RE: **Article II - ELECTION OF MAYOR AND ALDERMEN, Sec. 6. - Board of supervisors of elections.**

“(b)

“Before appointing any supervisors of election, the city council shall request the city central committees representing the two (2) leading political parties of the state in the city each to designate **at least four (4) eligible candidates for the position to be filled, by the second Monday in February. If a city central committee fails to nominate the required number of candidates as provided herein, the mayor shall submit a list of nominees to the city council in addition to the central committee's list by the first Monday in March. (Monday, March 5, 2018).**

The city council shall appoint the supervisors by the second Monday in March.” (Monday, March 12, 2018)
