### A. Update from the Mayor

Mayor Gavin Buckley, City Council Remarks

Good evening. I want to start by thanking Alderman Schandelmeier and Alderwoman Finlayson for stepping in as acting mayor while I went on holiday with my family. We had a memorable trip with the kids and we had time to recharge.

As a council, we will be taking August off from meetings, so I would like to take a few minutes to tell you about some upcoming events. Please mark your calendars:

- We have ongoing concerts at City Dock on Sundays at 6 p.m.; this week we have an extra treat with a Thursday concert by the United States Naval Academy's blues and gold blues band from 7 to 9 p.m. This is a free concert. Grab something to eat or make a picnic. Chairs are provided, or bring your own. The heat will ease up a little - it should be fun!
- Also on Thursday in Eastport is the Tides and Tunes concert series continuing at the Annapolis Maritime Museum. That's from 6 to 9:30 p.m.
- On August 2, National Night Out will take place at various locations including Annapolis Gardens, Bay Ridge Gardens, the Mike Busch Annapolis library on West St, and Woodside Gardens. It will start at 5 pm and includes free food, games, community resources and fun. National Night Out is also known as America's night out against crime. It is a nationwide program and is an opportunity for neighborhoods to strengthen relationships and partnerships with police, fire and public safety.
- On August 5, the Annapolis Rotary crab feast will return to in person at Navy stadium. Tickets are on sale now. This is a huge charity event and they give away tens of thousands of dollars in grants to community organizations.
- On August 13, from 11 a.m. to 3 p.m. at City dock is a youth entrepreneur event. They are looking for young entrepreneurs, ages 10 to 17 to come out and showcase their ideas and vision and at the event, they will learn how to plan and market their amazing entrepreneurial ideas. Today the new Child Care Assistance grants, that's \$250,000 that is available to nonprofit organizations that provide childcare and youth programs and/or activities to families in

Annapolis. Each applicant is eligible for up to \$50,000 per grant cycle. The grant application portal is now open on the City website, through Sept. 5. The grants will be evaluated and funding released on a rolling basis. If there are funds left after the initial round of funding, a second period will open in January of 2023.

I want to thank Alderman Gay for his work with the office of community services and the city's MIT department for getting that up and running so quickly.

Lastly, we have officially launched the MPDU program for Parkeside Preserve. MPDU stands for Moderately Priced Dwelling Unit. These are brand new, four bedroom townhomes at below market pricing.

The regular cost for these units is \$570,000 and the MPDU cost will be \$351,506. There are income requirements based on your family size as well as other eligibility criteria, which is all spelled out on the website. You will need to qualify for a mortgage and fill out an application.
