Update from Mayor

Email Mitchell...

Welcome back everyone. I trust we all had a good August break and have come back refreshed and ready for a busy few months, and the last four Council meetings of this term, including tonight.

While we were off, our City Departments continued their work and we had some great events and outcomes for our community. Firstly, I'd like to thank the public safety teams of Annapolis Police, Annapolis Fire, and the Office of Emergency Management who supported National Night Out events at locations around the City, including Clay Street, Busch Library, Annapolis Gardens, Bay Ridge Gardens, and Woodside Gardens. These events are opportunities for community members to positively interact with law enforcement and public safety officials while promoting community partnerships that make all neighborhoods safer. Thank you!

We were also able to break ground on a project that has been years in the making: the new Robert Eades Park. I want to start by thanking our Planning and Zoning, Public Works, and Recreation and Parks teams for their efforts in working to get community input on the design and functionality of this space, and sourcing grants to fund the nearly half-million dollar project. The location of the park is a prime example of a beautiful waterfront site where access has been limited, or in this case, almost completely cut off for use. The new design gives our Clay Street, Homewood, and West Annapolis neighbors, along with residents of Morris Blum and students at J. Albert Adams Academy, a place to reflect, do a little fishing or crabbing, or even grab a sandwich while watching the birds do all the fishing! The new park is named in honor of Robert Eades and we were thrilled that Tavon and London Eades were able to celebrate the groundbreaking with us. I thank them for their remarks at the event, reminding us all of the outsized influence their dad had on this community before his untimely passing during the pandemic. We hope you'll join us for the ribbon-cutting in April.

over VMI – 52 to

Institute which ran a
workshop for municipal leaders here at City Hall.
The Public Private Partnership that has helped us fund the work at City Dock
through the
rebuilding of Hillman Garage is of great interest to local governments around

across this country. Annapolis is leading the way in resilience innovation and
we are excited to
support others facing their own infrastructure challenges.

I want to give a special shout out to Planning and Zoning Director Chris
Jakubiak and
Department of Public Works Director Burr Vogel for the work of their teams -
work that is being
recognized by our residents and businesses!
First Director Jakubiak got two recent letters. The first came from "Palate

our permitting staff
led by John Menassa.
I should note here that Dir. Jakubiak has instituted significant changes to
permitting with a goal
of streamlining the process. It seems that effort is paying off! Thanks Chris.
The other thanks goes out to our DPW team for their work on taming weeds
on City sidewalks
in areas around downtown. Alongside our beautiful baskets that line Main
Street, we are
working to keep our city looking beautiful. Thanks to Director Vogel and his
team, we have not
only had zero complaints this year (which is a first!) we've even received
kudos for a job well
done. Thanks to all involved in keeping our City looking beautiful!

For the purpose of authorizing and empowering the City of Annapolis (the “City”) to issue and sell, upon its full faith and credit, (i) one or more series of its general obligation bonds in the aggregate principal amount not to exceed \$73,561,499 (the “Bonds”), pursuant to Sections 19-301 through 19-309, inclusive, of the Local Government Article of the Annotated Code of Maryland, as amended, and Article VII, Section 11 of the Charter of the City of Annapolis, as amended (the “Charter”), (ii) one or more series of its general obligation bond anticipation notes in anticipation of the issuance of the Bonds in the maximum aggregate principal amount equal to the maximum aggregate principal amount of the Bonds (the “Notes”), pursuant to Sections 19-211 through 19-221, inclusive, of the Local Government Article of the Annotated Code of Maryland, as amended, and the Charter and (iii) one or more series of its general obligation bonds to refund specified bonds previously issued by the City in the aggregate principal amount not to exceed 120% of the principal amount of bonds to be refunded (the “Refunding Bonds”), pursuant to Section 19-207 and Sections 19-301 through 19-309, inclusive, of the Local Government Article of the Annotated Code of Maryland, as amended, and the Charter; providing that the Bonds, Notes and Refunding Bonds shall be issued and sold for the public purpose of financing and refinancing certain capital projects of the City as provided in this Ordinance; prescribing the form and tenor of the Bonds, Notes and Refunding Bonds; providing for the method of sale of the Bonds, Notes and Refunding Bonds and other matters relating to the issuance and sale thereof; providing for the disbursement of the proceeds of the Bonds, Notes and Refunding Bonds; covenanting to levy and collect all taxes necessary to provide for the payment of the principal of and interest on the Bonds, Notes and Refunding Bonds; and generally providing for and determining various matters relating to the issuance, sale and delivery of the Bonds, Notes and Refunding Bonds.
