21 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**  
22 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

24 **Chapter 7.40 – PEDDLERS, HAWKERS, AND ITINERANT MERCHANTS**

- 38 A. Itinerant merchants or transient vendors who have obtained a use and occupancy permit  
39 pursuant to Title 21, Chapter 12 of the City Code may conduct business during any hour  
40 unless specified differently in that permit or by law.
- 41 B. Peddlers, hawkers, and itinerant merchants operating in conjunction with special events  
42 shall only conduct business during the permitted hours of the special event.
- 43 C. Peddlers selling from house to house shall only conduct licensed activities between nine  
44 a.m. and eight p.m.
- 45 D. All other peddlers, hawkers, and itinerant merchants shall only conduct licensed activities  
46 between eightSIX a.m. and nine p.m.
