25 County and Municipal Employees (AFSCME) 3162, and AFSCME 3406 for the Fiscal

28 **WHEREAS**, the City of Annapolis and Local 400, Local 1926, AFSCME 3162, and AFSCME
29 3406 employee organization has, through appropriate officials or their

34 memorandum of Collective Bargaining Agreement between the City of Annapolis
35 and Local 400, Local 1926, AFSCME 3162, and AFSCME 3406 for the Fiscal
36 Years 2022 through 2024 is hereby submitted to the City Council for its ratification
