This is a tough time for family, colleagues, coworkers, and friends. I'd like us to take a few

We also have some happier news tonight: I would like offer congratulations to our newest

Alderperson Harry Huntley who was appointed by the Democratic Central Committee last week

to replace Elly Tierney as the representative for Ward One. Welcome Harry! I've been greatly impressed by Harry's commitment and knowledge and I know he'll work hard

to make a positive difference for Ward 1 and all our residents.

As we move into the final year of this Council's term, Harry had kindly agreed to fill Elly Tierney's

committee roles as well so that we have maximum continuity and stability in what will be a big

year of delivering for Annapolis!

Since July, the Mayor's Office African-American Outreach team has been

leading a series of

"Pop Up Tours" in a different part of town each week on Thursday afternoons. These are highly

successful engagements in the communities that are not always in a position to come to us to

access services. So far, we've been to Bywater, Bay Ridge Gardens, Robinwood, Woodside

Gardens, Eastport Terrace, Clay Street, Allen Apartments, Annapolis Gardens, and Bloomsbury

Square.

This Thursday, the Pop Up Service fair will be in Admiral Oaks, then on September 19 in

Bowman Place. On September 26 we will be at Morris Blum; on October 3rd at Wilbourne

Estates, and our last Pop Up will be at Harbour House on October 10th. At each event, we are joined by amazing partners including the Office of Community Services,

APD, & OEM, as well as County Partners such as AA Power; and a number of non-profits who

provide community services and resources. Plus, there is always free food, refreshments, games

and much more.

The feedback so far has been great. One resident of Bloomsbury Square took the time to call

and say thank you for thinking of the residents in her community.

So, if you see our teams in your neighborhood, bring the kids and come out to say hello and

help spread the word to neighbors and friends so that everyone has a chance to connect. We'd

love to see you there!

Last week, the team held another great event - our first joint Expungement Fair, held in

partnership with the County and the State at the Busch Library. This event was coordinated by

Teona Hayes, of our Naptown Anti-Dope team, whose work centers on substance use disorder

and prevention.

In total, 125 people got low-level and driving offenses cleared off their records - all of which

which can be a barrier to jobs and opportunity.

Surrounding the room, community organizations and state officials had booths set up with

everything from overdose prevention/Narcan giveaways to information to job training and even

job opportunities.

These are the kinds of things that City government can do to make a real difference in the lives

of our residents. Having trusted and credible community members and advocates lead this work

is so important and has been a focus of this administration's outreach effort. I'd like to congratulate Teona Hayes of the Naptown Anti-dope Move(meant) and the whole

outreach team for this very successful event that literally has the power to

change people's

lives.

We plan to hold more Expungement Fairs in the future so look out for those.

Tomorrow afternoon, we will have a visit from the Mayor of Fremantle,

Australia. As most of

you know, that's the part of the world that I called home before I came to America. Fremantle is

right next to my home town of Perth, the capital of Westetn Australia.

Like Annapolis, Fremantle is known for its maritime history as a port city and for its historic

architecture.

The population of Fremantle is also similar to Annapolis — they've got about 35,000 people to

our 39.000 residents.

Tomorrow I look forward to showing Mayor Hannah Fitzhardinge around Annapolis, including

meetings and a presentation here at City Hall. We will also initiate a Sister-City agreement

together tomorrow to celebrate all our cities have in common and the enduring friendship

between the U.S. and Australia. We've sent an invitation to all council members and directors to

join us and I hope to see you!
