Explanation:This budget revision reflects the fourth quarter transfer for the following:

- 1. It transfers funding from Facilities salaries and benefits to contractual services to allow the Division to install blinds in Chamber's and clean ducts in City buildings. The division had salary savings due to vacancies.
- 2. It transfers funding from contractual services to salaries and benefits to pay for contractual employees hired by the City.
- 3. It transfers funding from Planning and Zoning salaries and benefits to Fire salaries and benefits and contractual services. Planning and Zoning has salary savings due to vacancies and the Fire Department is experiencing overages in overtime due to soft vacancies. The Fire department's electricity account is trending over budget. The City's energy consultant is analyzing this trend.
- 4 It transfers funding from Contingency to Snow salaries and benefits to cover personnel costs associated with Winter Storm Blair.
- 5. It reallocates funding within Recreation and Parks. The Parks division experienced savings due to vacancies and the Camps division will not expended its budget. Seasonal salaries for Pip Moyer, Health, and the Pool are trending higher than anticipated.
- 6. It reallocates funding from the Compensation Contingency account to various divisions for the classification and compensation study results.
- 7. It reallocates funding within Transporation to pay for the increase cost of fuel and oil.
