#### A. Update from the Mayor

Good evening. Last Friday was Earth Day and we had a full two days where residents got involved. We started with a tree planting ceremony at Georgetown East Elementary School. Then at City Dock, we had an event where Rep. John Sarbanes announced a \$300,000 planning grant for the reimagining of City Dock.

The City Dock work is around \$40 million project, most of it covered by our concession payment from Hillman, but every additional dollar we get from the federal or state government will help us get this across the finish line. A few weeks ago, at the end of session, the State announced \$10 million in funding support.

I appreciate that our federal and state partners recognize the need for these resiliency projects. Climate change is accelerating. It will be hard for cities like Annapolis to keep up with the necessary infrastructure upgrades. More important is how we pay for these projects.

As I said on Friday, alongside the Naval Academy's resiliency work funded by the Department of Defense, the City Dock project is representative of around one mile of our 17 miles of waterfront in the City, most of which is private property.

We have a lot more projects, but getting a start in an area that is an economic engine for our City is important to all future resiliency efforts.

Also on Friday, the Art in Public Places Commission, along with City environmental staff including Raycine Hodo and Jackie Guild opened a new exhibit that will be at Pip Moyer through the end of May and I encourage you to go see it.

The exhibit is a partnership with the PVA program at Bates Middle School. Talented middle school students were tasked with creating artwork of Maryland birds in celebration of Bird City Day.

More than 450 bird species have been identified and documented in Maryland with more than half nesting in our state. Annapolis is part of the East Coast flyway, an important bird migratory route. We want people to create bird-friendly environments and we thank students for participating and highlighting the importance of birds to our ecology.

On Saturday, scores of residents participated in Greenscape, our annual program to plant in public areas in the City. Volunteers beautified more than 64 locations! I thank Marissa Witlinger of Annapolis Recreation and Parks for her work on organizing this annual tradition and we of course thank our residents who turned out in force to green up the common areas of their community. What a difference a day makes!

Speaking of projects that we are moving forward on, the rebuild of Hillman Garage, which began in early April. You have all seen the trailer go up on Gorman Street, the hauling out of extraneous materials from inside the garage and on Friday last week the chain link fence going up. We will close the garage to parking on May 2, one week from today, after the Spring Sailboat Show.

If you have not already visited [www.accessannapolis.com](http://www.accessannapolis.com), you can find information about our vendor AMRP's alternative mobility plan and how we will move you around town during the 14-month closure.

You may have already seen the purple bus traversing downtown, our rebranded free

downtown shuttle. At each stop along West Street, Duke of Gloucester and Main Street, you will find the new magenta signs. Scan the QR code to see the location of the busses during service hours. We will also be offering a downtown electric trolley from Gotts Garage around to Calvert Garage, Maryland Avenue, and Main and West Streets.

In mid-May our on-demand ride share service through the VIA app will go live from fixed destinations all over the City. That will be \$2 for the first passenger and \$1 for additional riders.

In all, the new garage will take 14 months to build. It will have more parking spaces, gateless entry and exit, smart park technologies, EV charging stations, solar panels on the roof and 125 percent stormwater capture. It is expected to open by the end of June 2023. I should note that there are penalties for the contractor to run late on the job and rewards for them to finish early so they have every incentive to finish within that 14 month window.

The new garage is going to be amazing and we are all going to love it when it reopens next June.

I would like to give a shout out to Jared Littmann for chairing the Ward Boundaries commission. I know their work will not come before us for a few weeks or maybe even months due to budget and scheduling conflicts. We do not have municipal elections this year, so it is not a requirement to have this work product finalized before county elections in the fall. I know this has been a monumental task that was put before this group.

They used demographic data to come up with three maps and after public input, they chose map C. You can download the map from the city website using the keywords: Ward Boundaries Commission.

Once we have a formal presentation to the Council, this will become an ordinance and follow the regular council procedures with rigorous public debate and amendments and votes.

It is not an easy task - the commission was tasked with drawing the boundaries to include roughly the same number of constituents. They heard loud and clear that folks did not want neighborhoods divided between council members. I thank Hilary Raftovich from my office, Chairman Littmann, the commissioners, and the public for coming out to offer public input.

This summer, the City is going all out to offer as many opportunities for young people as possible. We will have a number of summer camps through Recreation and Parks - the signup portal on the Rec and Parks website went live at the end of March.

However, we will also be offering a number of camps through other programs and for those who want to give their kids something to do, but do not think they can afford camp, please reach out to our office of community services. They will have reduced rate and free camp offerings for swimming and on-water activities, team sports, academics and more.

Summertime enrichment activities are good for our kids - it not only gives them something to do, it can expose them to their areas of interest, expand their worldview... and it is fun!

Speaking of summer fun, the Kenneth R. Dunn Municipal Swimming Pool at Truxtun Park has an opening Day of Saturday May 28! We are working to ensure that all children have not only passes to get into the pool but free transportation to the pool this summer.

We are working within the guidelines of the law to help support the Housing Authority in their efforts to open the pool this summer at Harbour House/Eastport Terrace.

This pool facility is run entirely by HACA and they have indicated that they do not have sufficient funding to open the pool this summer. We offered direct financial assistance, which they have declined.

William Rowel from my staff is working to ensure that the funding and staffing is in place. It looks like we have support for getting the pool open with funding from outside organizations, including the Annapolis Police Foundation, thanks to Judy Buddensick, Charting Careers with Erin Snell and the Annapolis Department of Recreation and Parks under Director Archie Trader.

We know that providing safe, fun, and consistent activities for young people is a number one priority. Children need recreation and a place to cool off on hot summer days.

I talked a little about this last council, but it looks like the city's acquisition of the property that was once Carr's Beach, Sparrow's Beach and Elktonia is on the agenda for the Board of Public Works on Wednesday.

I have assurances from the Governor that this is going to get a quick approval for the Project Open Space funding totaling nearly \$5 million dollars. The city is kicking in \$1.3 million and the county an additional \$300,000.

This is a legacy parcel of land in our City. Once the site of segregated blacks-only beach, Carr's was a stop for the likes of Ray Charles, Sarah Vaughn, Stevie Wonder, Ella Fitzgerald, Chuck Berry, James Brown and a host of well-known bands and musicians of the era making it a must-stop location at the urging of our own DJ Hoppy Adams.

We have a diorama in City Hall that tells more of the story and those panels are also available on the City website - you can get to it right from the home page. I thank Governor Hogan and our state and county partners for helping us to make this acquisition possible and I look forward to a celebration at the site in the coming months.
