23 **FOR** the purposes of adopting a Five-Year Consolidated Housing and Community  
24 Development Strategic Plan for the period beginning July 1, 2016 through June 30, 2020.

26 **WHEREAS,** the City of Annapolis has prepared a Five-Year Consolidated Housing and  
27 Community Development Strategic Plan to implement the Community Development Block  
28 Grant Program which funds housing and community development activities within the  
29 municipality; and

31 **WHEREAS,** this document represents a five-year strategy covering the period beginning July  
32 1, 2016 through June 30, 2020; and

34 **WHEREAS,** under the Consolidated Plan regulations, the U.S. Department of Housing and  
35 Urban Development (HUD) requires that local jurisdictions develop a comprehensive vision that  
36 aims to develop viable urban communities by providing decent housing, a suitable living  
37 environment, and economic opportunities, principally for persons of low and moderate-income  
38 levels; and

40 **WHEREAS,** to meet HUD requirements to participate in the Community Development Block  
41 Grant Program, it is necessary for the City of Annapolis to adopt this Consolidated Plan.

43 **NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the  
44 Five-Year Consolidated Housing and Community Development Strategic Plan for the period  
45 beginning July 1, 2016 through June 30, 2020 is hereby adopted.
