F. Update from the Mayor

Mayor Gavin Buckley Remarks City Council Meeting Monday, May 13, 2019

Thank you everyone for joining us tonight.

Yesterday morning, I was very pleased to not only wish my wife and all the moms in Annapolis a Happy Mother's Day, I was thrilled to welcome the Police Unity Tour to our City and ride out of town with them. They raise funds for the fallen officer memorial in Washington, DC. Each year they ride 400 miles on their bicycles ending in DC to remember those who gave their lives while protecting the

public. Each year they stop in Annapolis for an overnight because they love this City. It was an honor to be the first mayor in the City's history to ride with them.

Last week we hosted the City Dock Action Committee Public Meeting at Pip Moyer Center. What an amazing turnout. There were 200 people in the room, actively participating in a conversation about the future of City Dock, our historic downtown and the direction of our City.

Thank you to everyone for helping to move this forward. We have our subject matter experts working in the Working Teams and they'll have their first reporting out to the Action Group in about ten days.

I'll remind everyone that this is an implementation strategy - they're working on ways to implement the ULI study ideas. I am very excited about how this is moving along. Thank you again to **Eileen Fogarty**. She's got some tough cookies to deal with but she does it with grace, wit and determination.

Speaking of City Dock, we have made HUGE. Huge! strides in alleviating flooding along Dock Street at City Dock. The Annapolis City Department of Public Works opened up the storm drains and installed an innovative solution to the ongoing coastal flooding.

It's a pump system, like a sump pump in your basement that will push the water out when it gets too high in the storm drain. Alongside that is a backflow preventer, think of it like a doggie door that only lets the water go out to Ego Alley, but it doesn't let the water from Ego Alley back up into the parking lot.

Let me say this loud and clear: It seems to be working. We have had a few extraordinary high tides in the past week, the kinds that would've left the businesses along Dock Street with floodwaters lapping at their doors and into their businesses.

I went by the other day when the National Weather Service had predicted high coastal flooding and it was dry as a bone.

I'll mention some names during the citation portion of tonight's meeting and congratulate the people who worked on this project specifically; but for now I want to thank **Alderwoman Tierney** who spearheaded this project and whose history as a civil engineer helped inform the idea to move the water away like they do on construction sites.

I'd like to also thank **David Jarrell** and **Lisa Grieco** from Public Works for swiftly working to get this implemented to give those businesses relief.

This is the way City government should work. We are working together to better the lives of the people who live, work and play in our City.

We are now working on the Compromise Street side.

On Sunday, May 5, I read the Proclamation opening the election for Ward Six

Council seat. It's already disarming to be sitting here without Alderwoman Henson, but we move forward together as a City and Council.

The special election will take place on June 4, that's the primary date. On July 2, we'll have a general special election. Please note that the board of supervisors of Elections has designated ONE polling place: Eastport Community Center. Filing deadline is tonight at 9 p.m. Again, the filing deadline for the Ward Six Special Election is TONIGHT at 9 p.m.

For One Annapolis, we had a very successful Safe Spring Break event, where we offered students an opportunity to have a safe place to spend their time off from school. We hosted 400 at Pip Moyer; 120 of those were children, with a basketball clinic, soccer, music, food and fun.

Also for One Annapolis, we hosted Naptown Anti-Dope Movement or NAM 5 event at Pip Moyer with substance abuse resources, Narcan training, recovery testimonials and Peer Support. Our next one is at Morris Blum on May 25.

We had the Annapolis Pride kickoff the first week of May. This will be the first Pride Parade in the City's history. It will take place on June 29. To coincide with that, I was happy to introduce **Max Huber** as the first LGBTQ-plus liaison to the Mayor's office. He joins **Amy Mi-YEZ**, the LGBTQ liaison in the Annapolis Police Department in serving our community. We are striving to ensure that our City is welcoming to people from all walks of life and I hope residents are confident they have people to turn to who understand their issues and unique concerns.

Earlier this month, our Office of Emergency Management staff attended a conference in Atlanta Georgia, "the Prescription Drug Abuse and Heroin Summit." The gathering brought stakeholders from across the nation to focus on developing harm reduction strategies and creating a network of advocates for substance use prevention, access to treatment, enforcement, education and recovery.

Representing the City at the conference were **Deputy Chief Kevin Simmons, Mary Kate Seborowski, John Barnickel** from the Office of Emergency Management, From my office, **Tola Ajayi**. From Police, **Captain Mark Seidel**, and from Fire, **Captain Aaron Edwards**.

Fire Chief David Stokes also reported, separate from the Atlanta trip but pertaining to the opioid epidemic that Captain Edwards was nominated to receive a service award from the Anne Arundel County 100 Club for his programs: "Your Life Matters" and "Narcan Leave Behind."

Last week, acting Planning and Zoning director **Sally Nash** hosted the kickoff event to develop the 2020 Comprehensive Plan. This process creates a broad

statement about community, where stakeholders try to look 20 years ahead to see what kinds of goals and strategies can be implemented to ensure healthy communities, healthy economies and healthy environments.

There is a big component of public input and data collection associated with this effort. I'd like to thank Director Nash as well as the following people who worked on the kickoff but will also be involved in this process as it unfolds:

- Tom Smith, Chief of Current Planning
- Theresa Wellman, Chief of Community Development,
- Hope Stewart, Small/Minority Business Coordinator

The Comprehensive Plan will deal with land use, environment, water resources, sea level rise, housing, transportation, parks and green space, and growth, among other priorities. Go to Annapolis.gov and use the keywords "2020 Comprehensive Plan" to learn more.

This coming Friday, May 17, in front of Market House, I want to remind everyone of National Bike to Work Day. 8 a.m., we'll have a rally there to promote all of the good things cycling can do for you personally and for the community and the environment. To remind you of some of the reasons why cycling is good:

- It creates no carbon emissions,
- It reduces traffic and parking demand,
- It is good cardiovascular exercise,
- It has a low impact on road infrastructure,
- It is something people of all ages can do,
- It reduces car and insurance payments, and
- It strengthens our economy by making the City a more attractive place to live, work and visit.

Speaking of environmental priorities, I want to note the UN Report on Biodiversity last week that cautioned that the actions of us humans will result in the looming extinction of more than one million species of plants and animals.

Sometimes these reports seem distant and unrelated to Annapolis or Maryland or

the US. But what is happening in other parts of the world affects us. There are actions we can take:

- Create biodiversity in your own neighborhood by selecting native plants or trees. Pick ones that you do NOT see in your neighbor's yard. This helps create native plant diversity in your neighborhood;
- Support efforts to restore streams and rivers to encourage more species by providing habitat;
- Try not to use pesticides and herbicides in your yard and encourage neighbors to do the same;
- Support efforts to slow climate change

I want to ask you to mark your calendars and get your tickets for an upcoming free event, the first in a series that will take place in partnership with Historic Annapolis, the City and Maryland Hall. It is a speaker series and the first one is May 20 with former Charleston Mayor Joe Riley.

He was the mayor of Charleston for 40 years. That is 10 terms, from 1975 to 2016. He took the city from a decaying urban center in the 1970s and 80s and built it into a top cultural destination by the time he left office in 2016.

King Street, the main street in downtown Charleston, was once a place you wouldn't want to go. Now it is one of the ten best shopping streets in America. Think Fifth Avenue and Michigan Avenue and Rodeo Drive. But it wasn't just about retail.

Riley worked to push the city into a new way of thinking about race. He was determined to be a bridge builder. He included African Americans in his City administration for the first time in the City's history. And Charleston was the first southern City to observe the Martin Luther King Jr. Holiday.

Riley also had tremendous strains during his time in office. Hurricane Hugo in 1989 wrought destruction on the city he was trying to rebuild. In June of 2015 when a gunman opened fire in the Emanuel AME Church, Riley had to deal with the aftermath of a mass shooting in his community.

I think that the Honorable Mayor Riley will have some things to share with the residents of our city and I encourage everyone to get a free ticket and come to Maryland Hall to hear what he has to say.

Finally, the Council starts addressing the Budget tonight. I want to thank City Manager Teresa Sutherland and Finance Director Jodee Dickinson for taking the lead in giving us a budget that is the most transparent, complete, and responsive to the Charter and laws.

One year ago, management of City finances were hanging by a thread. As a new City Manager, Teresa went to work to prepare and rework a budget for the Council to pass last year. During this year, Teresa and Jodee have sifted through where money was in pockets and prepared a Mayor's budget that can withstand any financial scrutiny.

We are working by a Council appropriation standard, departments living by their budget or getting supplemental appropriations passed by the Council, leaving behind unappropriated, unauthorized, unlawful spending from revolving funds.

This has been a monumental task for the last several months. The City is fortunate to have such able, professional employees. I hope Council Members share my respect and appreciation for Teresa and Jodee.

CITY OF ANNAPOLIS NOTICE OF A PROPOSED REAL PROPERTY TAX

INCREASE - The City Council of City of Annapolis proposes to increase real property taxes.

- 1. For the tax year beginning July 1, 2019, the estimated real property assessable base will increase by 2.109%, from \$6,670,084,346 to \$6,810,780,652.
- 2. If City of Annapolis maintains the current tax rate of \$0.7380 per \$100 of assessment, real property tax revenues will increase by 2.109 % resulting in \$1,038,339 of new property tax revenues.
- 3. In order to fully offset the effect of increasing assessments, the real property tax rate should be reduced to \$0.7228, the constant yield tax rate.
- 4. The City of Annapolis is considering not reducing its real property tax rate enough to fully offset increasing assessments. The City of Annapolis proposes to adopt a real property tax rate of \$0.7380 per \$100 of assessment. This tax rate is 2.109 % higher than the constant yield tax rate and will generate \$1,038,339 in additional property tax revenues.
