16 **2019 Annapolis Film Festival – Circulator Fee Waiver**

18 **FOR** the purpose identifying the 2019 Annapolis Film Festival Special Event that will
19 be held during March 21-24, 2019; and waiving the fee for running the circulator
20 during that event.

21
22 **WHEREAS,** from March 21-24, 2019, the City of Annapolis will entertain the 7th Annual
23 Film Festival in the Arts District of Annapolis, Maryland; and

24
25 **WHEREAS,** the 2019 Annapolis Film Festival Special Event is expected to welcome
26 over 15,000 participants and attendees from different parts of the country
27 and the world, bringing much needed commercial stimulus to the businesses
28 located within the City as well as tremendous enjoyment to residents and
29 visitors; and

31 **WHEREAS,** enthusiastic film connoisseurs will experience a cinematic immersion,
32 mingling with filmmakers and industry guests, they also will enjoy the
33 colonial ambience and can take advantage of the intimacy and walkability
34 of the Festival, located within the City’s historic district and downtown Arts
35 and Entertainment District; and

37 **WHEREAS,** the Annapolis Film Festival theme is Voices Strong. Minds Open. and is
38 the largest and most diverse arts event in Annapolis, entertaining a 26
39 percent African-American audience, and offering five showcases of
40 independent film that embrace diversity; and

42 **WHEREAS,** the Annapolis Film Festival desires to provide transportation for its patrons
43 using the circulator on routes other than the established routes for which the
44 City will incur additional cost, and

1 **WHEREAS**, Section 6.04.210 of the City Code requires persons using City facilities,
2 including vehicles not used on an established route, to pay the full fees of
3 the City's cost to provide the service; and

5 **WHEREAS**, the Annapolis City Council wishes to waive the fee for running the
6 circulator during the 2019 Annapolis Film Festival in recognition of its
7 significance to the residents of our City.

10 **NOW THEREFORE**,

11

12 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the fee for running
13 the circulator for the additional 15,000 people during the 2019 Annapolis Film Festival is
14 hereby waived in recognition of the significance of the special event to the residents of our
15 City.

17 **AND, BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that
18 this resolution shall take effect from the date of its passage.
