25 **FOR** the purpose of establishing that a license for peddlers, hawkers, and itinerant
26 merchants pursuant to Chapter 7.40 of the Annapolis City Code is not required
27 from 2016 through 2019 for the United States Sailboat Show, Inc./United States
28 Powerboat Show, Inc. and for Cruisers University, Inc. in association with leases
29 signed with the City of Annapolis.

31 **WHEREAS**, the City has entered into a series of leases with United States Sailboat
32 Show, Inc./United States Powerboat Show, Inc. and Cruisers University,
33 Inc. for the lease of certain property at the City Dock area for boat shows to
34 be held from fall 2016 through spring 2019; and

36 **WHEREAS**, on July 25, 2016, the Annapolis City Council passed Ordinance 8-16
37 amending the requirements related to a license for peddlers, hawkers, and
38 itinerant merchants pursuant to Chapter 7.40 of the Annapolis City Code;

41 **WHEREAS**, a license for peddlers, hawkers, and itinerant merchants is not required
42 pursuant to Chapter 7.40.020.A.13 on those days of the year and at those
43 places and times as are designated from time to time by resolution or
44 ordinance of the Annapolis City Council.

1 **NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL**
2 that a license for peddlers, hawkers, and itinerant merchants pursuant to Chapter 7.40 of
3 the Annapolis City Code shall not be required for the following entities, days, places and
