## Update from Mayor

Thank you for being with us tonight.

I would like to take a moment to grieve and reflect on the tragic Francis Scott Key bridge collapse overnight. Baltimore is a major American port, critical to global commerce. Our entire region will feel the effects as we continue recovery efforts for months, and perhaps even years.

The City of Annapolis stands prepared to offer assistance to our friends and colleagues in the City of Baltimore, Baltimore County, Anne Arundel County, Maryland Department of Emergency Management, Maryland Department of Transportation and the United States Coast Guard.

Early this morning, Annapolis Fire and the Annapolis Office of Emergency Management deployed members of the Incident Management Team to assist with the response. The City of Annapolis stands ready to offer continued assistance to the teams engaged in the continuing rescue, recovery, and rebuilding efforts.

If we could take a moment of silence now for those now presumed to have perished in this tragic and unthinkable incident.

You may have noticed a moderate flooding forecast from NOAA for Annapolis yesterday, today and likely tomorrow. These are typically forecasts where we deploy public safety teams to close Compromise Street when the water overtops the bulkhead alongside Fleet Reserve Club and then spills out into the street, making it impassable. When Compromise Street is closed, folks from Eastport trying to get downtown have to go the long way around and it is quite an inconvenience. Our City Dock work will provide a more permanent solution in the future but that is a couple of years away.

In the meantime, one of the technologies we learned about from the Netherlands has proved to be an effective and inexpensive solution here in Annapolis and over the past few moderate flooding events has helped keep Compromise Street open.

I want to thank Department of Public Works Director Burr Vogel and his team for the deployment and engineering of this solution. Keep up the good work!
