21 **FOR** the purpose of supporting the decision of the Maryland Health Care Commission
22 approving the Anne Arundel Medical Center’s application for a Certificate of Need to
23 offer a cardiac surgery program within Annapolis and Anne Arundel County.

25 **WHEREAS,** the Maryland Health Care Commission approved the Anne Arundel Medical
26 Center’s application for a Certificate of Need to offer a cardiac surgery program
27 within Annapolis and Anne Arundel County, and

29 **WHEREAS,** on May 22, 2018, the Prince George’s County Circuit Court upheld the
30 Commissions’ decision to award clearance to Anne Arundel Medical Center to
31 offer a cardiac surgery program within Annapolis and Anne Arundel County, and

33 **WHEREAS,** the UM Capital Health Region has appealed the decision of Prince George’s
34 County Circuit Court resulting in a further delay of the much needed cardiac
35 surgery program within Annapolis and Anne Arundel County; and

37 **WHEREAS,** the City of Annapolis seeks to promote private programs and services that benefit
38 the health and well-being of its citizens, and

40 **WHEREAS,** the Anne Arundel Medical Center has been a primary and excellent partner with
41 the City in addressing the healthcare needs of its population for more than a
42 century, and

44 **WHEREAS,** the absence of a cardiac surgical program is a critical gap and the only missing link
45 in Anne Arundel Medical Center’s ability to provide comprehensive cardiac
46 services, and

WHEREAS, Anne Arundel Medical Center is the best suited medical facility to operate a cardiac surgery program within Annapolis and Anne Arundel County, and

WHEREAS, Annapolis is the capital of the State of Maryland, and one of few state capitals in the United States without a cardiac surgery program, and

WHEREAS, access to prompt, accessible and affordable cardiac services is a critical factor in the future welfare of not only Annapolis residents, but also the hundreds of thousands of visitors it receives each year, and

NOW, THEREFORE,

BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the Maryland Health Care Commission conducted a comparative review of Anne Arundel Medical Center’s Certificate of Need application and the Commission’s decision to approve Anne Arundel Medical Center’s cardiac surgery program should be upheld on appeal.
