17 **A ORDINANCE** concerning

18 **Capital Budget Fiscal Year 2015**

20 **FOR** the purpose of adopting a capital budget for Fiscal Year 2015; and appropriating funds  
21 for expenditures for the Fiscal Year 2015 capital budget.

24 **WHEREAS,** pursuant to Section 6.16.030 of the Annapolis City Code, on March 10, 2014,  
25 the Mayor submitted to the City Council a capital budget for the ensuing fiscal  
26 year and a capital improvement program for the ensuing five fiscal years; and

28 **WHEREAS,** on \_\_\_\_\_, 2014, the Annapolis City Council held a public hearing on the capital  
29 budget for the City of Annapolis for Fiscal Year 2015; and  
30

31 **WHEREAS,** O-9-14 was referred to the Planning Commission, which held a meeting after  
32 proper public notice, to receive evidence and testimony as it judged to be  
33 relevant to the consideration of the capital budget and capital improvement  
34 program; and

36 **WHEREAS,** the attached capital improvement budget for Fiscal Year 2015 is submitted to  
37 the Annapolis City Council for its consideration and approval.

40 **NOW, THEREFORE:**

41 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**  
42 **COUNCIL** that pursuant to Section 6.16.030 of the Annapolis City Code, the capital budget for  
43 Fiscal Year 2015, attached to this ordinance and made a part hereof, be and the same is hereby  
44 adopted and approved.

46 **SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**  
47 **ANNAPOLIS CITY COUNCIL** that funds for all expenditures for the purposes specified in the  
48 capital budget for Fiscal Year 2015 are hereby appropriated in the amounts therein specified

1 and will be used by the City in the sums itemized in said budget hereby adopted for the principal  
2 objectives and purposes thereof, and the total sum of funds herein provided for the respective  
3 departments and major operating units thereof, boards, commissions and agencies.

5 **SECTION III: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**  
6 **ANNAPOLIS CITY COUNCIL** that this Ordinance shall take effect on July 1, 2014.
