D. Update from the Mayor

Good evening.

Just over three weeks ago, five people just doing their job as journalists in a local paper's newsroom were murdered.

This tragedy has forever changed these five families, the survivors of this massacre, the entire newsroom's families, our city, our state, our country and indeed, the entire world that is troubled by this attack on the Free Press.

And it has impacted me significantly and personally. Never did I imagine that as Mayor I would be dealing with the deadliest attack on press in the history of our country.

What happened at The Capital affected all of us in many different ways. Many of us knew the victims personally. All of us understand the impact this paper has had in our town for more than 300 years.

All of us know this was an attack on the freedom of the press.

And I will not stand by and let people forget the names of Wendi Winters, Rob Hiaasen, Gerald Fischman, Rebecca Smith, and John McNamara.

I went to each of their funerals. I met their families and learned more about their beautiful lives.

And many of the family members and reporters said to me and in fact, said to the world in many different ways, please do not forget about them. Don't let their lives be forgotten.

My energy about this event comes from our conversations and interactions with the journalists of The Capital Gazette and the families.

There is no right way or wrong way to grieve. Everyone processes grief and trauma in different ways. It's never too early or too late to show your support for the families.

Several weeks ago, we announced that the City wanted to host a benefit concert to help these families and urge the protection of the First Amendment – Freedom of the Press.

There's outpouring of support and our office endlessly fields requests from people asking how they can get involved and show support.

Our corporate community has called offering their financial assistance as well.

We have come together as a community to show our support and love for these families, for our local paper's journalists and our first responders.

I am extremely proud to be Mayor of such a compassionate city.

There is a healing power in music and free speech – That is the driving force behind this. This benefit concert will bring together our community while raising funds for these families and survivors, as well as recognizing the bravery of our first responders. The City of Annapolis should have an opportunity to express its support for the families, the newspaper staff, and protection of freedom of the press. This is how I emotionally came to where I am tonight. This event is NOT a political statement. Elected officials are invited to attend, but they are not speaking. This is NOT about gun control. This is about supporting the families, honoring our first responders, and protecting press freedom. For those who say it's too soon: There is a tradition of holding concerts to bring a healing power through music and raise money for victims. There was a concert for 9/11 shortly after the deadliest attack on US soil. Just 10 days after the Haiti earthquake, there was a benefit to raise money for 200,000 people killed. These kinds of concerts help the people who were the victims – whether it's the families, the survivors, the free press. It helps them. These events help heal. Tonight, we have on first reader, a resolution to consider this benefit concert a City of Annapolis sponsored special event. It is my hope that our City will support this benefit concert for The Capital Gazette, support the defense of the freedom of the press, and recognize the bravery of our first responders and approve the City's sponsorship, just as our city sponsors events like the Tug of War, the Eastport Parade of Lights, the Naval Academy band concerts, and our numerous parades. I will end my comments tonight with three quotes: "Journalism can never be silent: That is its greatest virtue and its greatest fault. It must speak, and speak immediately, while the echoes of wonder, the claims of triumph and the signs of horror are still in the air." Henry Anatole Grunwald "If your help ends at thoughts and prayers, I don't want them. What I want is action." Selene San Felice, Capital Reporter. "As a survivor of the Capital Gazette tragedy, I am sad to see some have concerns about the upcoming Annapolis Rising Press Freedom Concert. With memorials at Bestgate gone and life moving on, I appreciate the efforts to put on the show. Wish all supported it fully." I am asking this City Council to come together and put the city on record as supporting a benefit for these families and our newspaper
