17 **FOR** the purpose of expressly confirming the appointment of Michael La Place as the Director
18 of Planning and Zoning; and consenting to compensate the Director.

20 **WHEREAS,** pursuant to Section 3.08.030.F of the Annapolis City Code, the appointment and
21 initial salary of the Director of Planning and Zoning is subject to confirmation by
22 the City Council; and

24 **WHEREAS,** the Director of Planning and Zoning position became vacant on November 4, 2021;

27 **WHEREAS,** Tricia Hopkins, Human Resources Manager of the City of Annapolis, conducted a
28 thorough review of Mr. La Place’s qualifications and determined in her professional
29 opinion that Mr. La Place’s qualifications exceed the minimum requirements of the
30 Annapolis Charter and that Mr. La Place by virtue of his background, education
31 and experience is more than qualified to hold the position of Director of Planning
32 and Zoning; and

34 **WHEREAS,** pursuant to the foregoing City Code provision, the City Council is required to
35 expressly consent to the confirmation and compensation of the Director of Planning
36 and Zoning.

38 **NOW, THEREFORE,**

40 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that Tricia Hopkins, Human
41 Resources Manager of the City of Annapolis, conducted a thorough review of Mr. La Place’s
42 qualifications and determined in her professional opinion that Mr. La Place’s qualifications exceed
43 the minimum requirements of the Annapolis Charter and that Mr. La Place by virtue of his
44 background, education and experience is more than qualified to hold the position of Director of
45 Planning and Zoning.

2 **AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the City
3 Council expressly confirms the appointment of Mr. La Place to the position of Director of Planning
4 and Zoning and consents to compensate Mr. La Place as Director of Planning and Zoning at a
5 Grade A20, Step 10, commencing May 9, 2022.
