**A RESOLUTION** concerning

**2025 Salary Review Commission Members**

**FOR** the purpose of approving members of the Salary Review Commission established by Resolution 42-24 on September 27, 2024.

**WHEREAS,** Article II, Section 4(b)(1) of the City Charter requires that “Not later than one (1) year before the date of any general municipal election for the election of mayor and aldermen, the city council shall appoint a commission consisting of not less than three (3) nor more than seven (7) residents of the city to review the compensation and allowances to be paid to the mayor and aldermen during the ensuing terms of office”; and

**WHEREAS,** Article VI, Section 2B(d) of the City Charter states that “The compensation of the city manager shall be fixed by the mayor according to the provisions of an executive pay plan formulated by the Council Compensation Commission and adopted by ordinance.

**WHEREAS,** The Annapolis City Council adopted R-42-24, establishing the 2025 Salaries Review Commission on the pay and compensation for the Mayor, City Council, and City Manager to be effective for the four years beginning December 1, 2025.

**NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the 2025 Salary Review Commission membership shall consist of:




