

Statement of Interest – Why should be appointed to this board/commission?

I would like to be part of the winning team under Mayor Gavin Buckley. I have been a lifelong resident of Maryland and have resided in Annapolis for the last 30 years. I have a great deal of pride and familiarity with our state and city. I am a graduate of Frostburg State University ('77) and obtained a master's degree from the University of Maryland University College ('96).

I also possess the work experience that lends itself to this position. I was an auditor for the Federal Government working for various Inspector General Offices for approximately 40 years. As an Audit Director, I was responsible for managing the conduct of audits, inspections, and evaluations to prevent and detect fraud, waste, and abuse.

My objective in this position would be to improve the economy, efficiency, and effectiveness of the City's programs and operations.

Work experience (titles and duties)

I worked as an auditor for the Office of the Inspector General for 3 different Federal agencies; Department of Transportation (7 years), Department of the Interior (8 years), and Department of Housing and Urban Development (25 years). I held various positions audit positions from an auditor, auditor-in-charge, and then an Audit Director. As an Audit Director, I was responsible for the planning and issuance of many audit reports containing recommendations for system improvements, program changes, or financial control problems. Also, I was responsible for managing and overseeing multiple audit teams in regional offices throughout the country.

Included in my duties was the oversight of the Disaster Recovery programs as a result of natural disasters (i.e., Katrina and Sandy) and other disasters (911). Billions of dollars were appropriated for these programs that were of high priority and of major congressional interest.
