A. Update from the Mayor

**Mayor Gavin Buckley Mayor's Remarks City Council Meeting - Virtual
7 p.m. February 14, 2022**

I want to start out tonight by sharing information about an incident that happened over the weekend in the Obery Court/Clay Street community - an incident where two children were shot.

First: the children are going to survive. A 14-year-old male was released from the hospital the same night and the 10-year-old female is in stable condition. Thank goodness for that because this situation could have been MUCH worse.

On the issue of transparency, I know that I want, and the public wants, all the information about an incident like this straight away. We push for transparency, but we can't expect the police to give the public information they don't have.

It takes time. The police interview victims and suspects, they interview neighbors and bystanders. They seek to collect and process evidence, including ballistics as well as video surveillance from multiple sources. None of this happens in an instant.

Let me share with you some of the facts as they have been relayed to me and my staff this afternoon by Annapolis Police detectives. For a more full accounting, the Annapolis Police Department posts the most updated information at Annapolis.gov. Search the keyword "Police Media Release."

The shooter turned himself in about 45 minutes after the incident took place. The shooter surrendered his weapon to police. Annapolis Police conducted a search of the home and found no additional weapons. Police sent charging documents to the court and it is the COURT who makes

decisions about bail and whether to hold or release a suspect.

Because juveniles are involved, there are legal protections and confidentiality that must be respected. Make sure you know where your kids are and make sure to hug them tight.

Onto a completely different topic now, the Super Bowl was last night and if you watched the game you may have felt like every second advertisement was about electric vehicles.

Tonight we have a public hearing on 0-40-21, the 100% Electric Mobility Plan, which is part of our plan to move Annapolis to adopt and support electric vehicles and the necessary infrastructure.

If all of the major car companies are putting the kind of money behind electric vehicles and showcasing that effort in a series of commercials during the Super Bowl, the most expensive time slot for American television during the ENTIRE YEAR, well then maybe we here in Annapolis are onto something too.

On page 4, after line 3, insert "AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the City will work with the Maryland Department of the Environment "MDE" toward increasing the fine amounts that the City may impose for violations of stormwater pollution regulations." Seconded. CARRIED on voice vote.

Alderman Savidge moved to amend R-7-22 as follows:

On page 2, strike lines 1 down through 31 and insert:

"WHEREAS, there have been recent and repeated discharges of pollution into Quiet Waters Park that could have been minimized or prevented through strict adherence to our Code and standards; and WHEREAS, certain contractors have repeatedly violated our sediment control and pollution prevention Code provisions and standards, which conduct demonstrates a need for increased enforcement to deter such violations; and WHEREAS, the enforcement agency has at times provided a contractor 5 days or more to resolve violations, while the City Code requires daily compliance; and WHEREAS, because of recent violations of sediment control and pollution prevention Code provisions, it is clear that the City's enforcement agency needs to increase its facilitation of compliance, pro-activeness, and attentiveness by contractor's on development sites to prevent further violations; and, WHEREAS, stop work orders were not issued by the enforcement agency for repeat violations and failures to adhere to the City's compliance orders and corrective notices; and" and strike lines 39 down through 43. Seconded. CARRIED on voice vote.

Alderman Savidge moved to amend R-7-22 as follows:

Amendment #6:

On page 3, in line 38 after "of" insert "significant" and in line 40 after "requirements" insert "and had multiple deficiencies that contributed to the discharge". Seconded. TABLED ~ "Means to postpone or suspend consideration of a pending motion."

Alderwoman Finlayson moved to amend R-7-22 as follows:

Amendment #7:

On page 3 strike lines 9 down through 11 and insert:

1. "A Stop Work Order shall be issued to any project that has an off-site illicit discharge caused by contractor negligence." Seconded. CARRIED on voice vote.

Alderwoman Finlayson moved to amend R-7-22 as follows:

On page 3 strike lines 12 down through 14 and insert:

2. "A Stop Work Order shall be issued if the contractor makes no effort to re-mediate the conditions identified in the Field Correction Order within the time frame given." Seconded. CARRIED on voice vote.

On page 3 strike lines 30 down through 34. Seconded. CARRIED on voice vote.

On page 3 strike lines 35 down through 37 and insert:

"9. "Field Correction Notices shall require corrections within a timely period, reviewed and approved by the Director. All Field Correction Notices shall be posted in a location accessible to the general public." Seconded. CARRIED on voice vote.

City Manager Jarrell and Public Works Director Johnson were present and answered questions from the council.

Alderman Savidge moved to amend R-7-22 as follows:

Page 3, line 30 - If field correction notices are issued, corrective actions shall be discussed with the enforcement agency to determine effectiveness of the corrective actions. Seconded. CARRIED on voice vote.

Strikes text on page 3 lines 35-37 (number 9.), insert "Field correction notices should require corrections within at least 24 hours. If a longer period of time is needed for corrections, this must be reviewed and approved by the Director and posted at a location accessible to the general public." Seconded. CARRIED on voice vote.
