#### A. Update from the Mayor

Mayor Gavin Buckley City Council Remarks 10 June 2022 - 5 p.m.

We have a lot to get through at this meeting - welcome to the shortest Mayor's remarks ever!

Three things I want you to know about - and information about all three is available on the City website at [www.annapolis.gov](http://www.annapolis.gov).

**Thing #1:** Juneteenth is next Saturday with a gala, a parade and a festival. The gala is a

ticketed event on Friday, June 17. The parade is Saturday, June 18 and steps off at noon from City Dock, going up Main Street and over to Maryland Hall. The festival immediately follows the parade at Bates Athletic Complex with food, vendors, music and entertainment. The parade and festival don't have an entry fee. Please park at Navy Stadium for \$5 per vehicle and take the free shuttle which will run from 11 a.m. to the conclusion of events.

I will be walking with my team in the parade and I am inviting all City staff to join us. We are #10 in the lineup and - City staff - needs to be at City Dock by 11:30 next Saturday.

I'd like to remind everyone that City offices will be closed for Juneteenth on Monday, June 20. The Pip Moyer center will be open, but Stanton will be closed. Trash pickup will NOT be affected and Annapolis Transit will operate on a regular schedule.

**Thing #2: On June 24, in partnership with Maryland Hall, we will be giving Eastport born-and-raised writer and producer Rodney Barnes a Key to the City!**

Rodney grew up here, went to local schools, attended Howard University and then went to Hollywood to follow his passion. He got a writing job on My Wife and Kids in the 1990s, became a graphic novelist, including the series Killadelphia, became a producer on the Boondocks and other TV series. Produced award shows including BET and the Oscars, and most recently wrote and executive produced the HBO series "Winning Time," about the Los Angeles Lakers.

That's a lot of accomplishments! It's a ticketed event, but the tickets are FREE!

And Thing #3 - on June 28 we will host a wreath-laying ceremony at the Guardians Memorial at 9:30 a.m. with the families of the victims as well as the newsroom and public safety survivors. The public is invited to attend. Afterwards, we will return to City Hall for light refreshments and the unveiling of a tribute painting by local artist Mark Peria that was donated to the City.

With the epidemic of gun violence we are witnessing in this nation, this solemn remembrance is an opportunity for our community to come together. I hope to see you there.
