30 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**  
31 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

33 **Title 12 - VEHICLES AND TRAFFIC**

34 **Chapter 12.32 - Special Residential Parking Districts**

35 **Section 12.32.110 - Permit--Fee--Renewal.**

37 A. **Fee Established.** The fee for a residential parking permit in special residential parking  
38 districts shall be established by resolution of the City Council.

39 B. ~~The fee shall be payable at the time of the submission of the application for the permit. The~~  
40 ~~permit year shall commence on July 1st and terminate on June 30th. The fee shall be~~

5 **Fee Requirements.**

6 1. The fee shall be payable at the time of the submission of the application for the  
7 permit.

8 2. ~~The permit year shall commence on July 1st and terminate on June 30th.~~

9 ~~The fee shall be prorated based on the number of months that a resident requires the~~  
10 ~~permit from the date of issue to the end of the fiscal year based on the number of~~  
11 ~~months that a resident requires a permit.~~

12 ~~Permits are valid for one year, starting at the permit issuance date.~~

13 3. The City shall not refund any permit issued due to disuse.
