We are coming to the end of a fantastic and celebratory Black History Month - a time we remember, honor and celebrate the contribution, resilience, and success of Black community members and ancestors, who have been integral to the life, growth and success of Annapolis, our State, and our country.

Over the month we've flown the flags of the African Diaspora; honored the contribution of local Churches and their communities; held community events such as our Maryland recipe hunt (to source traditional local recipes); filmed leading Black community members to learn more about local history; featured local Black artist Comacell Brown in our City Hall art exhibition; and marked each day with a social media post highlighting places of significance to create a virtual Black History Month walking tour.

I'd like to thank everyone involved in organizing and delivering these events and programs over the past month and, in particular, Alderman Da Juan Gay, William Rowel, and Adetola Ajayi; staff at the Pip Moyer Recreation Center; our community engagement teams and everyone in the community who helped or participated. I'd also like to thank Alderwomen Sheila Finlayson and Rhonda Pindell-Charles who facilitated and supported many of our events.

Last Friday, we concluded our formal celebrations with an amazing and inspiring celebration of Black History here in the Council Chamber. The Chamber was packed to capacity with community members, city staff, and parents of school children from all around Annapolis.

The evening included multifaceted conversations, jazz, gospel & dance performances, spoken word, and a history lesson on the meaning of African American cuisine. We left the decorations up to give you a taste of the night and to mark the significance of Black History month for this Council and for our city.

Thank you to everyone who attended on Friday, to all those who performed and spoke, and to everyone who helped with organization and support - including City Staff and our wonderful caterer: Kelly McGraw and the Kitchen.

I'd particularly like to thank William Rowel who planned, organized and delivered this great event with creativity and professionalism. Great job!
