19 **AN ORDINANCE** concerning

21 **Annual Operating Budget: Fiscal Year 2018**

23 **FOR** the purposes of adopting an operating budget for the City of Annapolis for Fiscal Year
24 2018; appropriating funds for expenditures for Fiscal Year 2018; defraying all expenses
25 and liabilities of the City of Annapolis and levying same for the purposes specified;
26 specifying certain duties of the Director of Finance; and specifying a rate of interest to be
27 charged upon overdue-property taxes.

29 **WHEREAS,** pursuant to Section 6.16.010 of the Annapolis City Code, on April 3, 2017,
30 the Mayor submitted to the City Council the proposed annual operating
31 budget for Fiscal Year 2018; and

33 **WHEREAS,** on _____, 2017 the Annapolis City Council held a public
34 hearing on the operating budget for the City of Annapolis for Fiscal Year
35 2018 and the constant yield tax rate; and

37 **WHEREAS,** the citizens of Annapolis, employees of the City of Annapolis and all
38 interested persons have been given an opportunity to express their views
39 concerning the Fiscal Year 2018 budget; and

41 **NOW THEREFORE:**

43 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS**
44 **CITY COUNCIL** that a tax rate of (\$0.644) on each one hundred dollars (\$100.00) of
45 assessable property in the City of Annapolis be and the same is hereby imposed on all assessable
46 property for the fiscal year ending June 30, 2018, to be collected pursuant to the provisions

1 contained in Article VII of the Charter of the City of Annapolis and all other provisions
2 pertaining to tax levies in said Charter, the said tax rate of (\$.644) on each one hundred dollars
3 (\$100) shall be used for the operation of the General Fund of the City of Annapolis.
4

5 **SECTION II: AND BE IT ESTABLISHED AND ORDAINED BY THE**
6 **ANNAPOLIS CITY COUNCIL** that a tax rate of One Dollar Ninety-Four Cents (\$1.94) on
7 each one hundred dollars (\$100.00) of personal and operating property in the City of Annapolis
8 be and the same is hereby imposed on all personal and operating property for the fiscal year
9 ending June 30, 2018, to be collected pursuant to the provisions contained in Article VII of the
10 Charter of the City of Annapolis and all other provisions pertaining to tax levies in said Charter,
11 the said tax rate of One Dollar Ninety-Four Cents (\$1.94) on each one hundred dollars (\$100)
12 shall be used for the operation of the General Fund of the City of Annapolis.

14 **SECTION III: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY**
15 **THE ANNAPOLIS CITY COUNCIL** that it shall be the duty of the Director of Finance of the
16 City of Annapolis to collect the sums set apart for the several funds, to keep separate receipts and
17 amounts thereof, to deposit the same to the credit of funds as required by the several Acts and
18 Ordinances relating to and providing for the several bonds issued, and to receive on account
19 thereof only current money and legal tender of the United States.

21 **SECTION IV: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY**
22 **THE ANNAPOLIS CITY COUNCIL** that taxes levied by this Ordinance remaining unpaid on
23 October 1, 2018, except for taxpayers who elect to make a partial payment before October 1 with
24 the balance due later as allowed by State law, shall be overdue, and from and after that date shall
25 bear interest, to be collected with said taxes, at the rate of one and one-half percent (1.5%) per
26 month until paid.

28 **SECTION V: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**
29 **ANNAPOLIS CITY COUNCIL** that the annual operating budget for Fiscal Year 2018
30 available at <http://www.annapolis.gov> is hereby approved and finally adopted for such fiscal
31 year; and funds for all expenditures for the purposes specified in the budget for Fiscal Year 2018
32 are hereby appropriated in the amounts therein specified and will be used by the City in the sums
33 itemized in said budget hereby adopted for the principal objectives and purposes thereof, and the
34 total sum of funds herein provided for the respective departments and major operating units
35 thereof, boards, commissions and agencies.

37 **SECTION VI: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY**
38 **THE ANNAPOLIS CITY COUNCIL** that this Ordinance shall take effect on July 1, 2017.
