- 21       1. Class B-1. Alcoholic beverages shall be served only with meals and sales shall  
22       be only between the hours of six a.m. and twelve midnight, Monday through  
23       Saturday. The premises shall not contain a bar open to the public.
  - 24           i. Class B-1.a - In addition, off-sale Monday through Saturday  
25           during hours.
  - 26           ii. Class B-1.b - In addition, off-sale Sunday during authorized hours  
27           (special Sunday License).
  - 28           iii. Class B-1.g - In addition, the sale of draft beer is permitted in  
29           refillable containers per § 12.335 of this Title.
  - 30           iv. Class B-1.X - Alcoholic beverages shall be served only with meals  
31           and sales shall be only between the hours of six a.m. and two a.m.,  
32           Monday through Saturday. The premises shall not contain a bar  
33           open to the public.
