**WHEREAS**, Ordinance 38-20 adopts certain building codes in accordance with the Code of Maryland; updates certain building codes; corrects technical errors; specifies enforcement procedures; and specifies appeal procedures; and

**WHEREAS**, Resolution 45-20 amends certain code section references in the Fiscal Year 2021 Fines Schedule that were modified by the Building Code updates of O-38-20.

**NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the Fiscal Year 2021 Fines Schedule is amended as follows:


