19 **FOR** the purpose of authorizing sales by certain vendors in the City Dock area of the
20 Historic District during the Fall 2017 U.S. Sailboat and Powerboat Shows.

22 **WHEREAS,** on July 25, 2016, the Annapolis City Council passed Ordinance 8-16
23 amending the requirements related to a license for peddlers, hawkers, and
24 itinerant merchants pursuant to Chapter 7.40 of the Annapolis City Code;

27 **WHEREAS,** Section 7.40.090 of the City Code allows the City Council to designate
28 certain days of the year, places and times when peddlers, hawkers and
29 itinerant merchants may be licensed to sell in the Historic District or a
30 nonresidential area.

32 **NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL**
33 that the following vendor sales in the City Dock area of the Historic District during
34 October 5-9 and October 12-15, 2017, as described more fully in the Staff Report, are
35 hereby approved pursuant to Section 7.40.090 of the Municipal Code of the City of
36 Annapolis.
