As we enter the last week of Black History Month, I want to give a shout out to all who have helped shape and organize the City's program of events and activities. These have included a Black Business Brunch; a night celebrating Black art and culture here at City Hall last Friday; and our showcase series on the State of Black Annapolis, held each Tuesday of this month at the Busch Library.

Each of these State of Black Annapolis events has involved a panel discussion and audience Q&A focused on different themes including art, youth and history.

Tomorrow will be the last of the series and will focus on the contribution of Black Businesses and Entrepreneurs. We'll celebrate ten Black-owned businesses that have been successful in operation for decades. Be sure to stop by this free event which will start at 5:30 p.m. with a social hour, followed at 6:30 p.m. by a discussion and the business presentations to be made by our own Ald. Pindell Charles. It will all take place in the Campbell Chambliss Community Room of the Busch Library.

I want to thank all of the presenters who have made this weekly series a big success, along with everyone who has attended. I particularly want to thank our partners at the Busch Library for their support, and our African-American Community Engagement Leader Adetola Ajayi - who designed and organized the series along with our other Black History Month events. On February 15, Recreation and Parks Director Roslyn Johnson and I were joined by Blacks of the Chesapeake Founder Vince Leggett, Chesapeake Conservancy President Joel Dunn, The Conservation Fund's Bill Crouse, County Executive Steuart Pittman and members of the state delegation to announce the City's acquisition of the Dr. Parlett Moore property at Carr's/Elktonia Beach.

This acquisition is a vital step in achieving our vision of a community park and visitor's center that tells the amazing story of Carr's, Sparrow's and Elktonia beaches in the era of segregation. It is particularly satisfying that we were able to announce the acquisition during Black History Month.

As a refresher, in August of 2022, the City acquired the last bit of undeveloped land that was once Carr's and Sparrows Beach. Throughout 2023, we worked to get Dr. Moore's adjacent bay-front property by contributing City dollars and raising funds from our partners in county government alongside scores of private donors.

Now that we have secured both parcels of land for future generations, we can begin to implement our vision for the new Carr's Elktonia Heritage Park. The site will first get a resilience upgrade with coastal reinforcements for the beach. Then we will work to create a master site plan that will define and support an outstanding visitor

experience and tell this important part of Annapolis history.

The Resilience Authority of Annapolis and Anne Arundel County is a great partner in this work and in the coming days, they will be issuing an RFP for the work under the direction of Annapolis Recreation and Parks.

I want to thank all of our partners for helping to make this happen. I am very proud of what we've achieved and I consider it one of the legacy items of my administration. It shows how we can work together across jurisdictions and how we can honor all kinds of history in this City. Lastly, it shows how government can directly make a positive difference in peoples' lives.

We got some good news from the US Department of Housing and Urban Development - or HUD - last week.

The Transformation Plan for Eastport Terrace and Harbor House, which our community has been partnering with us to create through the Choice Neighborhoods Initiative, was approved by HUD.

That means we are on track to the next phase of the process where we may be eligible for up to \$50 million in assistance to reimagine those two public housing communities into mixed-income housing.

That will be a game changer for public housing in Annapolis. It isn't an overnight process, but I want to thank all of our neighbors who took the time to engage in this two-year process. As part of CNI, our residents voted on one of the early action items. We will now work toward improving pedestrian safety at the intersection of President and Madison Streets through place making.

We are working with the award winning firm, Graham Projects. They have completed similar projects in Baltimore, Hyattsville and other locations around Maryland.

Early action items are meant to inspire what's coming with the redevelopment and I look forward to seeing what the community comes up with!

1. The Director shall promulgate rules and regulations as necessary to successfully implement the program;

2 The Director shall consult with the City Manager, Transportation Board, and any authorized agent as defined in § 12.04.020 prior to promulgation of any rules and regulations.

B. The Transportation Board shall hold a public hearing on proposed regulations per § 12.32.050 before issuance by the Director.

C. Each regulation shall have the force and effect of law not less than 45 days after its issuance by the Director unless the City Council adopts a resolution objecting to the regulation within those 45 days."

On page 5, strike lines 9-23 and insert:

" A. Resident status for purposes of obtaining a resident parking permit for a motor vehicle is established by meeting the following:

1. Residence. The applicant has a current Maryland vehicle registration and current Maryland driver's license with an address in parking district;

2. Non-resident Owner. The applicant is owner of a residential property located in a Special Residential Parking District, and the property is designated as the owner's principal residence with the Maryland Department of Assessments and Taxation

3. Lessee Without Maryland-Licensed Vehicle.

a. The applicant is the tenant of a residential property in a special residential parking district that is licensed as a rental unit.

3. Lessee Without Maryland-Licensed Vehicle.

a. The applicant is the tenant of a residential property in a special residential parking district that is licensed as a rental unit.

b. Applicants must submit a copy of the lease and a copy of the current rental unit license. The parking permit expires with the lease.

4. Active Military. The applicant is on active military status and resides in the parking

district, as reflected in documents issued by United States military authorities. ";
