24 **WHEREAS,** Section 6.16.050 of the City Code requires that concurrent with the submission of
25 the proposed annual budget, the Mayor shall submit to the City Council a proposed
26 schedule of fees.

28 **WHEREAS,** The City Council adopted the FY 2025 fees schedule on June 10, 2024, but the fees
29 for sewer have been calculated differently by the City's rate consultant;

31 **NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the
32 Fiscal Year 2025 fees schedule be amended as follows:
