- **WHEREAS,** R-16-19 specified the fees that will be charged for the use of City services during FY 2020; and
- **WHEREAS**, R-20-20 amends the FY 2020 Fees Schedule to specify the fees that will be charged for use of the new City of Annapolis swimming pool effective April 1, 2020.

NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the FY 2020 Fees Schedule shall be amended as follows:
