- 1. THE CITY MANAGER SHALL SUBMIT A STAFF REPORT, AND THE FINANCE DIRECTOR SHALL SUBMIT A FISCAL IMPACT NOTE, ON EVERY ORDINANCE, CHARTER AMENDMENT, AND RESOLUTION NO LATER THAN THE DATE SUCH LEGISLATION IS TO BE HEARD AT PUBLIC HEARING.
- 2. ANY ORDINANCE OR RESOLUTION WAIVING OR REDUCING CITY FEES SHALL BE REFERRED TO THE FINANCE COMMITTEE AND THEN LIE ON THE TABLE AFTER WHICH SHALL BE READ THE SECOND TIME AND FINAL ACTION TAKEN.

SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that this ordinance shall take effect from the date of its passage.
