18 **FOR** the purpose of authorizing the filing of an application with the Maryland Transit
19 Administration of the Maryland Department of Transportation for a Sections 5303, 5304,
20 5307, 5309, 5310, 5311, 5316, and/or 5317 grants under the Federal Transit Act for a
21 total amount of \$1,400,625 (\$1,238,625 for transit operations and \$162,000 capital grant
22 for transit vehicle maintenance).

24 **WHEREAS,** the Maryland Transit Administration is the designated recipient in Maryland for
25 grants under the Federal Transit Act; and

26
27 **WHEREAS,** the Administrator of the Maryland Transit Administration of the Maryland
28 Department of Transportation is authorized to make grants to counties and to
29 local governments for public transportation programs or projects; and

31 **WHEREAS,** the contract for financial assistance will impose certain obligations upon the
32 applicant, including the provision by it of the local share of the project costs in
33 the program; and

35 **WHEREAS,** it is required by the United States Department of Transportation in accordance
36 with the provisions of Title VI of the Civil Rights Act of 1964 that, in connection
37 with the filing of an application for assistance under the Federal Transit Act, the
38 applicant give an assurance that it will comply with Title VI of the Civil Rights
39 Act of 1964 and the United States Department of Transportation requirements
40 thereunder; and

42 **WHEREAS,** it is the goal of the applicant that minority business enterprise be utilized to the
43 fullest extent possible in connection with this project, and that definite
44 procedures shall be established and administered to ensure that minority
45 business shall have the maximum construction contracts, supplies, equipment
46 contracts, or consultant and other services.
