23 **FOR** the purpose of accepting a bequest from the late Alderman Richard E. Israel and
24 approving a matching allocation of City funds to be used to purchase and install an
25 outside Tablet in honor of former Mayor Roger W. (Pip) Moyer and Joseph Zastrow
26 Simms.

28 **WHEREAS,** on or about June 23, 2015, Alderman Richard E. Israel made a bequest in the
29 First Codicil to his Last Will and Testament of \$1,000 to the City of Annapolis
30 as partial funding to establish a Tablet in honor of former Mayor Roger W. (Pip)
31 Moyer and Joseph Zastrow Simms; and

33 **WHEREAS,** a condition of the \$1,000 bequest is that the City of Annapolis shall contribute
34 up to \$1,000 to jointly fund the acquisition and installation of said
35 commemorative Tablet; and

37 **WHEREAS,** the Annapolis City Council wishes to express its gratitude in accepting this
38 generous bequest and acknowledges its willingness to jointly fund the
39 commemorative “Pip and Zastrow” Legacy Tablet.

41 **NOW THEREFORE,**

43 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the \$1,000 bequest from
44 the late Alderman Richard E. Israel is hereby accepted, and a matching allocation of City funds
45 up to \$1,000 is hereby approved to be used to purchase and install an outside Tablet in honor of

1 former Mayor Roger W. (Pip) Moyer and Joseph Zastrow Simms. Said funds shall be reflected
2 as an expendable trust on the City's accounting records.

4 **AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that this
5 resolution shall take effect from the date of its passage.
