1	<u>A.</u>	Definitions. In this section, the following words have the meanings indicated.		
2		1. "Coffee shop" is defined in § 21.72.010.		
3		2. "Delicatessen" is defined in § 21.72.010.		
4		3. "Food service facility" means an establishment licensed by the Anne Arundel		
5		County Department of Health to prepare or sell food for the public.		

1	4. "Mobile food service vendor" is defined in § 7.40.010.
2	5. "Plastic carryout bag" means:
3	a. A plastic bag provided by a retail establishment to a customer at the point
4	of sale that is not a reusable carryout bag.
5	b. A compostable plastic bag that meets the specifications of the American
6	Society of Testing and Materials International Standard D6400
7	specification for compostable plastics.
8	6. "Point of sale" means the physical or virtual place where a customer executes
9	payment for goods or services or receives goods or services.
10	7. <u>Restaurants.</u>
11	a. "Fast food restaurant" is defined in § 21.72.010.
12	b. "Standard restaurant" is defined in § 21.72.010.
13	8. "Retail establishment" means a store, food service facility, or any other
14 15	establishment that provides bags to its customers due to the sale of goods or
15	services.
16	9. "Reusable carryout bag" means a bag with stitched handles made of cloth or other
17	washable fabric or a durable material suitable for multiple reuses, specifically
18	designed and manufactured for numerous reuses, and not made of plastic film.
19	10. "Vending truck or cart" means a motorized or nonmotorized vehicle that changes
20	the location where a retailer can sell goods directly to customers.
21	B. Requirements.
22 23	1. A retail establishment shall not provide a plastic carryout bag to a customer
23	except as provided in Subsection C(3).
24 25	2. A retailer shall not provide a paper bag containing less than 50% post-consumer
25	recycled content.
26	3. The law shall be called the "City of Annapolis Plastic Bag Reduction Act."
27	C. Duties.
28	1. Charge for Bags.
29	a. Fee. Retail establishments may offer customers paper bags or reusable
30	carryout bags for a fee.
31	i. The fee for paper bags shall be at least ten cents (\$0.10) per bag;
32	ii. The customer shall pay the fee;
<i>∟</i>	ii. The customer shart pay the ree,

1 2	iii. The sales receipt shall reflect the number of bags provided to the customer and the fee collected for the paper bag(s);
3	iv. The retail establishment shall collect and retain the fee; and
4 5	v. Retail establishments shall not provide customers any rebate, exemption, or reimbursement for this paper bag fee.
6	b. Annual Exception. A retail establishment may provide free, reusable,
7	carryout bags:
8	i. For nine days each year between April 22 and April 30; and
9 10	ii. During a promotional period established by the retail establishment, up to 10 days per month.
11	2. Public Notice.
12 13	a. Must Be Posted. A retail establishment shall post notices at the public entrance to their establishment or each point of sale that:
14 15	i. <u>Customers should bring reusable carryout bags or may purchase</u> reusable carryout bags in the retail establishment;
16 17	ii. Each paper carryout bag purchase is subject to a charge, and the amount of the charge;
18	b. Bilingual. The notices shall be posted in English and Spanish.
19	3. Exceptions.
20	a. Allowed Plastic Bags. Plastic carryout bags are allowed for:
21	i. Bakery goods or unwrapped prepared foods;
22 23	ii. Bulk items, including fruit, vegetables, nuts, grains, candy, or small hardware items;
24	iii. Cigars or loose tobacco;
25	iv. <u>Dry-cleaned or laundered items;</u>
26 27	v. Freshly prepared hot or cold food, including sliced deli and foods prepared or ordered;
28	vi. Food and goods obtained at a farmers' market;
29	vii. <u>Ice;</u>
30 31 32	viii. Live creatures such as fish, insects, mollusks, or crustaceans from a retail establishment selling such items in the ordinary course of business;

1 2 3	2. Enforcement. The Deputy City Manager for Resilience & Sustainability or their designee shall issue a citation and levy fines or seek injunctive relief to enforce this section.
4	3. Offenses.
5 6	a. Failing to charge, collect, or retain at least 10 cents per paper or reusable carryout bag a retail establishment provides customers is a single offense;
7 8	b. The provision of one or more plastic carryout bags per consumer transaction at a single point of sale is a single offense;
9 10	c. <u>Multiple violations during a consumer transaction at a single point of sale shall constitute a single offense; and</u>
11 12	d. A fine may not be imposed against a retail establishment more than once in seven days.
13 14 15 16 17	4. Public Notice. The Deputy City Manager for Resilience and Sustainability or thier designee shall maintain and post on the City's website an annual record of the name and address of any retail establishment found to violate this section, including the date of the violation, the nature of the violation, and the amount of any fine imposed.
18 19 20	E. Fines. Fines for violation of any part of this chapter are set by the annual resolution of the City Council. The fine schedule can be found in the Appendix of the City Code.
21 22 23 24	SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that this Ordinance shall take effect six months after adoption.
