I'd like to knock down a rumor that the reimagining of City Dock will be the

end of this very Annapolis tradition of tug-o-war. First, we will work to ensure that this event can happen both during and after construction. Second, the best part of the new City Dock Park may be that the Annapolis side could become the place for the better party!

Since this is the last meeting before Thanksgiving, Black Friday and Small Business Saturday, I'd like to give you a heads up on a number of events and activities happening in the City over the holiday season.

This Friday, City offices are closed for Veteran's Day. Refuse and recycling pickups are unaffected. Pip Moyer will remain open, while the Stanton Center will be closed. Annapolis Transit will operate on a Sunday schedule.

On Saturday, at 11 a.m. the City will commemorate Veteran's Day with the Fleet Reserve Club in downtown. The public is invited to this free event.

Then we move to Thanksgiving and beyond. On the 23rd, Thanksgiving Morning, the annual Turkey Trot 5K fun run will be held. It begins in Eastport and continues over the Spa Creek bridge, through downtown, up King George to West Annapolis where runners turn around. Please note there are no road closures for this 9am race. Runners are expected to stay on sidewalks, but we ask drivers to use extra caution.

On Friday November 24th, otherwise known as Black Friday, City offices will be closed. And on the Saturday after Thanksgiving, it will be time to head to your favorite local retailers for Small Business Saturday.

Then, the Sunday after Thanksgiving is the Grand Illumination at Market Space where we will light the downtown Annapolis Christmas Tree.

From there, things will get even busier!

On Friday, December 1, from 5 to 9 p.m., it's the Maryland Avenue & State Circle retailers' Holiday Open House.

The following Thursday, Dec. 7 will be the first of three Midnight Madness nights in downtown. The alpacas will be out for the 7th and the 14th. Also on the 7th is the Menorrah lighting ceremony at City Dock for the first night of Hanukkah.

On Saturday, Dec. 9, we'll have the Eastport Yacht Lights Parade.

On Thursday, Dec. 14 is the second night of midnight madness and the City's holiday Open House right here in City Council Chambers from 4 to 6 p.m. Also on the 14th is the Inner West Street Holiday Fest with the first block of West

Street closed to traffic.

From Thanksgiving through to New Year, our holiday parking program will begin. It's two hours free at metered spaces and - for this year only - we will be offering one hour of free parking at Hillman Garage.

There are lots more events to follow in December but I look forward to telling you about those at our next meeting. Look for updates on the City website and social pages to keep up to date with all the great things happening around Naptown at this time of year.
