22 **FOR** the purpose of modifying the types of alcoholic beverages that may be consumed on the
23 Market House premises.

26 of Annapolis, 2022 Edition

30 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**
31 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

33 **Title 7 – BUSINESS LICENSES, TAXES AND REGULATIONS**
34 **Chapter 7.12 - ALCOHOLIC BEVERAGES**
35 **Section 7.12.100 Public consumption and possession.**

37 **A.** A person may not consume any alcoholic beverage or possess an open alcoholic container or
38 possess an alcoholic beverage container on which the seal has been broken in or on any of the
39 following areas or places within the City:

- 40
41 1. Any street, public way, highway, alley, sidewalk, road or parking area;
42 2. Any vehicle;
43 3. Any station or terminal;
44 4. Any park, playground, parking lot, or any other public facility leased, WITH THE
45 EXCEPTION OF THE CITY MARKET HOUSE, owned or operated by the City; and

- 1 5. On the premises outside the structure of any establishment possessing a valid alcoholic
2 beverage license, including any shopping center parking lot where there is an alcoholic
3 beverage licensed establishment located in the shopping center, and any parking lot
4 located adjacent to the premises of an alcoholic beverage licensed establishment.

6 B. The Alcoholic Beverage Control Board may permit the consumption of:
7

- 8 1. ~~Beer and wine~~ALCOHOLIC BEVERAGES in the City Market House. Any possession,
9 consumption or sale of ~~beer and/or wine~~ALCOHOLIC BEVERAGES in the Market
10 House must comply with all applicable requirements of this Chapter.
11 2. Alcoholic beverages in or on any of the places identified in Subsection A during special
12 events determined by the Mayor to be of significance to the City, or if, in the board's
13 judgment, the consumption would not be contrary to the public interest. Any action of the
14 board denying a request shall be accompanied by a written statement of the reasons for
15 the denial.
16

17 C. A person violating the provisions of this section is guilty of a misdemeanor and, upon
18 conviction, is subject to a fine or imprisonment, or both as established by resolution of the
19 City Council.

22 **SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**
23 **ANNAPOLIS CITY COUNCIL** that this ordinance shall take effect from the date of its passage.
